The report by the inspector general said PacifiCare was paid extra for treating patients with cancer or a dangerous bloodstream infection even though medical records did not describe those ailments. - 33. December 15, Memphis Commercial Appeal (Tennessee) Thirteen dams in west Tennessee repaired after flooding, erosion damage. Owners of 13 dams needing major repairs in west Tennessee have completed, or very nearly completed, the necessary work to fix potentially unsafe conditions or breaches, according to a Tennessee Department of Environment and Conservation (TDEC) official. TDEC is pursuing penalties against the owners of Garner Lake, and said the owners failed to meet deadlines for correcting problems with the dam.
