

# Daily Open Source Infrastructure Report 02 April 2013

## **Top Stories**

- A March 29 Exxon Mobil pipeline leak that spilled a few thousand barrels of crude oil, caused the evacuation of 22 homes in Arkansas and raised concerns about the Keystone XL pipeline that is awaiting approval from the State Department. *Washington Post* (See item 1)
- Southbound and northbound lanes were closed for several hours March 31 on Interstate 77 near the Virginia North Carolina border as a result of 17 separate crashes involving 95 vehicles. *NBC News* (See item 10)
- McCreary County school district cancelled classes March 29 and Highway 27 was closed between Highways 700 and 90 for more than 12 hours while crews cleaned up a chemical spill from an overturned tractor-trailer. WATE 6 Knoxville; Associated Press (See item 14)
- A bomb threat to Fort Hall Casino prompted an evacuation of 600 people from 13 buildings, residences within a quarter mile, and closed traffic in both direction on Interstate 15 for three hours before being deemed safe to reopen for business and traffic. *Associated Press* (See item <u>32</u>)
- A March 29 fire began on the first floor of a two-story building, inside a spa and led to more than 60 people being evacuated from the spa and adult day care facility as firefighters spend several hours fighting the blaze. *Bergen County Record* (See item <u>36</u>)

1. *April 1, Washington Post* – (Arkansas) **Exxon Mobil pipeline leaks 'a few thousand' barrels of crude oil in Arkansas.** A March 29 Exxon Mobil pipeline leak, that spilled a few thousand barrels of crude oil, caused the evacuation of 22 homes in Arkansas and has raised concerns about the Keystone XL pipeline that is awaiting approval from the State Department. By March 31 the company sent out 15 vacuum trucks and 33 storage tanks to clean up and temporarily store roughly 12,000 barrels of oil and water that was recovered.

Two men were arrested for attempting to steal more than \$4,000 worth of copper wires from St. Cloud businesses and were caught by a Design Electric worker when they were spotted in the facility. - 3. March 30, Associated Press (Texas) West Texas man sentenced for biodiesel scam. The owner of Absolute Fuels was sentenced March 29 to over 15 years in prison and ordered to pay \$55 million in restitution for a biodiesel scam that generated about \$42 million in revenue after he plead guilty in December 2012. The owner falsely claimed his company produced biodiesel fuel at a facility that did not exist. and 3 counts of violating the Resource Conservation and Recovery Act after they practiced unsafe disposal methods and intentionally deceived federal regulators by concealing their illegal acts.

The evacuation lasted for several hours and residents were allowed to walk back in the development but prevented from driving due to the strong gas odor.
