1. April 8, Reuters – (Texas) Shell ups estimated release from E. Houston pipeline leak. The original estimate of how much crude oil was released by a Shell Oil. Co. pipeline leak in east Houston from the West Columbia pipeline was increased by the company from 700 barrels of crude to 940 barrels. Crews were working to excavate around a section of the pipeline to identify where the leak originated and were preparing to remove oil believed to be buried underground.

Strong winds affected the Phoenix area and other places throughout Arizona, forcing highway closures for several hours, knocking out power to a few thousand homes, and creating health concerns as dust covered the State.

The company, whose products are sold nationwide, has a history of violating the Federal Food, Drug, and Cosmetic Act and failing to control risks of toxins in their manufacturing environment.
