Rox Coal Inc.'s Geronimo Mine in Somerset County was fined \$110,000 by the federal Mine Safety and Health Administration for intentionally creating a dangerous electrocution hazard that left a miner injured in October 2007. - 2. April 9, Salt Lake Tribune (Utah) Pipeline diesel still missing, though less than previously thought. Officials reported that Chevron still cannot account for thousands of gallons of diesel fuel that leaked from a March 18 pipeline spill at the Great Salt Lake. Estimated projections of how much diesel leaked were reduced to 21,000 gallons while cleanup efforts continued as authorities worked towards reopening the Willard Bay North Marina and Park by early June.
