1. *April 11, KMOX 1120 AM St. Louis* – (Missouri; Illinois) **Thousands remain without electricity in Missouri and Illinois.** At the peak of a severe storm nearly 45,000 Ameren customers in Missouri and Illinois lost power. As of April 11 there were still 23,327 homes in Missouri without electricity and nearly 3,000 without power in Illinois.

2. *April 10, Associated Press* – (California) **NRC staff signals ‘no hazard’ in San Onofre start.** The Nuclear Regulatory Commission stated that restarting the San Onofre nuclear power plant in San Diego County would not pose a significant safety risk, the first of several steps the plant must clear to restart. The plant has been offline since unexpected wear was found on water tubes in January 2012.

The incident caused a stretch of westbound lanes on Interstate 290 just north of Buffalo to close for several hours.

Both drivers suffered non-life-threatening injuries and all lanes were reopened once the scene was cleared.

The highway was blocked for around 5 hours.

13. *April 10, Help Net Security* – (International) **Hijacking airplanes with an Android phone.** A security consultant from n.runs AG in Germany demonstrated the ability to take complete control of commercial aircraft by taking advantage of two new technologies and by creating an exploit framework (SIMON) and an Android app (PlaneSploit) that delivers attack messages to an aircraft's Flight Management Systems.

14. *April 10, KCPQ 13 Tacoma* – (Washington) **Sticky situation: 20,000 gallons of glue-like liquid spill on I-5.** More than 20,000 gallons of a glue-like substance spilled onto the northbound lanes of Interstate 5 near Federal Way after a semi-truck crashed into a disabled minivan, leaving one person from the minivan in critical condition. The spillage forced the closure of three lanes on Interstate 5 for hours, backing up traffic for miles.

The bees are depended upon by California farmers to pollinate their crops and losing the bees could impact the production of nuts and fruit. 17. *April 10, U.S. Department of Labor* – (Connecticut) **US Labor Department's OSHA cites Nuway Tobacco Co. for combustible dust, electrical, mechanical and fall hazards.** Nuway Tobacco Company was cited by the Occupational Safety and Health Administration (OSHA) for 22 serious violations at its South Windsor manufacturing facility after OSHA found workers were exposed to fire and explosion hazards. The tobacco manufacturer faces \$59,869 in proposed fines. The firm is allowed to produce almost all of their frozen products, except for their seafood products. **jerky product due to misbranding and undeclared allergen.** Approximately 1,133 pounds of a pork jerky product were recalled by Formosa Food Company Inc. because of misbranding and an undeclared allergen, wheat, which is not declared on the label. The product was sold on the Internet and nationwide.

City officials said it will take 2 days to refill the two water towers.

The \$20 million cleanup cost will be borne by General Electric and Powerex, the two companies which occupied the site during the period of the leaks.
