1. April 15, WTRF 7 Wheeling – (West Virginia) 1 worker dies from injuries suffered in Tyler County gas explosion. A worker died from injuries suffered in an April 11 accident at the Eureka Hunter Pipeline operation that left two other workers injured after an explosion at the site.

The Utah Division of Water Quality requested Chevron to provide a report on cleanup operations and a response plan from a March 18 pipeline failure that spilled fuel in Willard Bay State Park near the Bear River Migratory Bird Refuge. The park is closed indefinitely as crews continue the site's cleanup.

Crews were on site for several hours working to contain a mix of oil and saltwater brine after an old storage tank ruptured near New Philadelphia, Ohio April 11. Authorities are investigating how the mix overflowed from a containment dike into two drainage ditches and into Beaver Dam Creek and claimed the age of the tank may have attributed to its rupture.

Authorities closed the off-ramp for about 3 hours until the occupant could be removed and the car taken away.
