An Idaho Correctional Institution-Orofino inmate faces more charges after a guard discovered he was utilizing an electric typewriter to correspond with law firms in order to make fraudulent claims in big case-action lawsuits and bankruptcies collecting nearly \$64,000 from settlements. The inmate deposited the money in his prison trust account and transferred most of it out to an investment account.
