Chrysler will install a trailer hitch to minimize the chance that the gas tank may be punctured during a rear-end collision.

Servers seized in the investigation held details of 30,000 bank customers, with the U.K. details alone potentially netting about \$92 million in fraud.

The virus has never been seen in North America before and is harder to control than previously believed.
