1. *July 11, CNN* – (International) **Workers pump mud into leaking natural gas well in Gulf.** Energy Resource Technology Gulf of Mexico stated that a well southeast of Port Fourchon, Louisiana, is leaking roughly 3.6 barrels of light condensate every 24 hours and workers are pumping mud into the well to try to stop the natural gas leak. The company was in the process of permanently plugging and abandoning the well when the leak started July 7 and after being plugged, began leaking again July 8, prompting the evacuation of the platform and shutdown of two adjacent working wells.

2. *July 11, Pittsburgh Tribune-Review* – (Pennsylvania) **Power outages, road closures remain day after heavy storms.** Roughly 22,000 Duquesne Light customers were without power July 11 after a series of flooding storms rolled through western Pennsylvania, prompting the closure of several roads as crews worked to restore service and clean up debris.

3. *July 10, U.S. Environmental Protection Agency* – (Texas) **Shell Oil to spend over \$115 million to reduce harmful air pollution at Houston area refinery and chemical plant.** Shell Oil and their affiliated partners reached a settlement with the U.S. Department of Justice and U.S. Environmental Protection Agency July 10 to spend at least \$115 million to control harmful air pollution from industrial flares and other processes and pay a \$2.6 million civil penalty to resolve alleged violations of the Clean Air Act at a refinery and chemical plant in Deer Park, Texas.

4. *July 10, Associated Press* – (Arkansas) **Exxon: Report blames Ark. pipeline bust on defects.** ExxonMobil and the Pipeline and Hazardous Materials Safety Administration were presented with an independent report blaming the failure of the ExxonMobil pipeline that sent 150,000 gallons of crude oil into Mayflower, Arkansas, March 29 on manufacturing defects after cracks near a seam that failed on the Pegasus Pipeline were found. ExxonMobil claimed they were still investigating the incident but the defects identified in the report reflected the core cause of the failure.

CONSOL Energy committed to building a centralized treatment plant after discharges released into Dunkard Creek from two mines were believed responsible for killing thousands of fish, mussels, and salamanders in 2009.

20. *July 11, Scranton Times-Tribune* – (Pennsylvania) **Increased sewage flow overwhelms plant, causes 72,000 gallons to leak into nearby creek.** Abington

Regional Wastewater Authority officials reported at a July 10 meeting that a 72,000 gallon raw sewage spill occurred at its plant after heavy rainfall in late June 2013 overwhelmed the plant and led to spillage into Leggetts Creek. The plant's pumps prevented an additional 650,000 gallons of raw sewage from spilling into the nearby creek and are in the process of bringing the plant into federal compliance.

Preliminary tests showed the powder was harmless and the county courthouse was scheduled to reopen July 11.

45. *July 11, Mississippi Business Journal* – (Alabama; Mississippi; Tennessee) **High water has TVA spilling at dams; farmland to be impacted.** Extreme rainfall and runoff in the Tennessee Valley prompted the Tennessee Valley Authority to release or spill excess water from 10 to 20 tributary dams and all 9 main channel dams along the Tennessee River's 652 miles in an effort to relieve areas in danger of flooding. The spilling is expected to last 1-2 weeks and has already impacted farmland and caused flooding in several cities along the Tennessee River, prompting authorities to close recreational areas temporarily.
