- July 17, Associated Press (New Mexico) NM reaches \$920K settlement with gas processor. New Mexico-based Occidental Permian Limited Partnership reached a settlement with the State Environment Department to pay a \$95,000 penalty and spend at least \$825,482 on new equipment after the department alleged the plant failed to fully report emissions from flaring events that exceeded permit limits for carbon monoxide, hydrogen sulfide, sulfur dioxide, and other pollutants in 2010.

- 2. July 17, Associated Press (California) California seeks record fines for 2010 pipeline explosion. California regulators amended a brief July 16 filed against Pacific Gas & Electric Co. to pay at least \$300 million in fines in connection with a deadly 2010 gas pipeline explosion that killed eight people and destroyed 38 homes in the San Francisco Bay area. Regulators originally recommended no fine, and instead called on the company to spend \$2.25 billion on pipeline safety.

- 3. July 16, Associated Press (International) Talos: Fewer than 420 gallons of condensate, small amount natural gas leaked from Gulf well. Talos Energy LLC reported less than 420 gallons of condensate and a small amount of natural gas escaped and evaporated after a well in the Gulf of Mexico leaked the week of July 8. The two wells that were temporarily shut down when the leak began have not yet resumed production.

4. *July 16, Forum of Fargo-Moorhead* – (North Dakota) **5 people injured in ND oilfield explosion.** Authorities are investigating an oilfield explosion at Trustian Oilfield Services in New Town July 16 that left five workers injured. The sheriff's department believed the fire started when the workers were removing a cover on an oil fuel tank and an electric drill ignited the blaze.

7. July 16, U.S. Department of Labor – (Texas) Oilfield Solutions Inc. cited for 33 safety violations by US Department of Labor's OSHA for exposing workers to hazards. The Occupational Safety and Health Administration cited Oilfield Solutions Inc. with 33 safety violations and proposed \$74,800 in penalties for deficiencies in Oilfield Solutions' process safety management program and for exposing workers to other workplace hazards at its Midland oil field chemical manufacturing plant. Sears reissued a recall on 795,000 Kenmore brand dehumidifiers made by LG and sold at Sears and Kmart stores after additional reports of fires and burns. - 11. July 16, U.S. News & World Report (National) Chrysler recalls more than 50,000

Jeep and Ram models. Chrysler issued a recall for 45,961 model year 2013 Ram 1500 vehicles due to a software issue that can disable the electronic stability control (ESC) system. Chrysler also issued a recall for 4,458 model year Jeep Grand Cherokee models due to a parking lamp issue.

Investigators are working to identify the outbreak source, though they suspected a raw vegetable product that is no longer on the market.

The department investigated a tuberculosis incident and notified the public in March, but did not test school children until May after discovering the disease was spread by a school janitor.
