### **Top Stories**

- Target Corp., stated January 10 that names, email addresses, and home addresses for up to 70 million customers were also stolen during a prior breach of its systems. *Bloomberg News* (See item 6)
- Ten people were injured in a chain reaction pileup on westbound Interstate 84 in Meridian, Idaho, closing a section of the interstate for 5 hours January 9 after 12 separate accidents blocked the area involving 46 cars and semi-trucks. *Idaho Press-Tribune* (See item 8)
- A Federal disaster declaration was issued after a chemical spilled from a 48,000-gallon tank into the Elk River January 9 compromised the public water system for nearly 300,000 people and forced businesses, government offices, and schools to close in several West Virginia counties. *CNN* (See item 14)
- The Owen County, Kentucky judge-executive declared a state of emergency after a water main break cut off the water supply to around 2,000 Kentucky American Water customers January 6. Frankfort State Journal (See item <u>15</u>)

The U.S. Department of Labor's Occupational Safety and Health Administration cited Black Hills Corp., doing business as Black Hills Energy in Pueblo, Colorado, with two safety violations and proposed penalties totaling \$75,000 after a worker was seriously injured when they came into contact with an energized power line while making repairs in July 2013. - 3. January 10, Nuclear Street (Louisiana) Frozen valve results in water spill at River Bend nuclear plant. Cold temperatures caused a valve to freeze and spill between 100 and 1,200 gallons of water from a cooling tower blow-down line at the River Bend nuclear power plant in St. Francisville January 7. The water was contained to the building and contained tritium well below drinking water standards. Source:

14. January 10, CNN- (West Virginia) In parts of West Virginia, water is only for

**flushing.** A chemical used in the coal production process spilled from a Freedom Industries' 48,000-gallon tank into the Elk River January 9, compromising the public water system for nearly 300,000 people and forcing businesses, government offices, and schools to close in several West Virginia counties. A Federal disaster declaration was issued as officials worked to determine the level of contamination while setting up water distribution centers as residents were warned not to come into contact with the water.
