Droidpak that is designed to infect Android devices connected to an infected Windows computer. The trojan then attempts to replace a legitimate South Korean online banking app if it is present on the device. The malware is also capable of intercepting and forwarding SMS messages.

order to steal private photos for posting to his Web site. The alleged hacker was also arrested.

January 23, Krebs on Security – (International) **Bug exposes IP cameras, baby monitors.** Camera manufacturer Foscam confirmed that a flaw exists in its MJPEG cameras and baby monitors running the .54 version of its firmware that could allow a user to log into a camera's Web interface without a password. Foscam expects to issue a new firmware version that closes the issue by January 25 and a workaround was also available.
