1. *January 31, Associated Press* – (International) **Crews lose control of gas rig off Louisiana coast.** Crews worked to secure an EnVen Energy Ventures natural gas well being drilled off the Louisiana coast January 30 after workers lost control. Most crew members were evacuated while essential personnel worked to vent gas off the rig and kill the well.

2. *January 31, Pottstown Mercury* – (Pennsylvania) **Berks woman admits to role in copper thefts from Pottstown-area PECO substations.** A Reading woman pleaded guilty to assisting three others in a scheme to steal copper ground wire from PECO Energy substations in the Pottstown area, taking over 140 pounds of copper wire from several substations between 2011 and 2012.

drive mechanism housings during a refueling and maintenance outage. The U.S. Nuclear Regulatory Commission stated that there was no adverse effect on safety, and the plant's operator plans to replace the faulty housings.

30. *January 31, Softpedia* – (International) **Experts find 28 security issues in Oracle's Java Cloud Service.** Researchers at Security Explorations analyzed Oracle's Java Cloud Service and found 28 security issues, 16 of which could be leveraged to bypass the Java security sandbox of a targeted WebLogic server environment. The vulnerabilities could also be leveraged to gain access to deployments of other users in the same regional data center, according to the researchers.
