Beck Aluminum Alloys Ltd., operating as Beck Aluminum Racine, was cited by the U.S. Department of Labor's Occupational Safety and Health Administration February 26 for 13 serious violations following an incident at its Racine, Wisconsin facility that exposed a worker to hazardous chlorine gas.

The NRC graded the incident as a Security Level IV. properly.
