Top Stories

- Officials are investigating after two miners were injured and then rescued after the roof of the D and F Mine in Schuylkill County, Pennsylvania, partially collapsed and trapped them March 3. WNEP 16 Scranton (See item 1)

1. *March 3, WNEP 16 Scranton* – (Pennsylvania) **Coal miners rescued in Schuylkill County.** Officials are investigating after two miners were injured when the roof of the D and F Mine in Schuylkill County partially collapsed and trapped them March 3. The injured miners were rescued and transported on a medical helicopter.

2. March 3, Kalamazoo Gazette – (Michigan) Piece of metal lodged in reactor at Palisades Nuclear Power Plant. Operators at the Palisades Nuclear Power Plant in Covert Township discovered a piece of metal from a broken impeller blade lodged in the plant's reactor vessel during a scheduled refueling and maintenance outage. Efforts to remove the metal debris were unsuccessful but plant operators do not believe the debris poses a threat to operations or safety.

3. March 4, U.S. Securities and Exchange Commission – (Illinois) Federal grand jury indicts CEO of Chicago-area company accused of defrauding investors in multi-

million dollar stock scam. A federal grand jury returned an indictment February 28 against the CEO and president of InfrAegis Inc., on charges of allegedly using false information to obtain more than \$9 million from investors between 2007 and 2013. - 4. *March 4*, *Softpedia* (International) **Bitcoin bank Flexcoin shuts down after hackers emptied hot wallet.** Bitcoin bank Flexcoin announced March 4 that it was shutting down operations after attackers leveraged a vulnerability and withdrew all Bitcoins from the bank's 'hot' wallet, around 900 Bitcoins worth over \$600,000. - 6. March 4, WSBT 22 South Bend (Michigan) Police: Speed, reckless driving cause deadly car-semi crash on I-94. A portion of the eastbound lanes on Interstate 94 between Benton Harbor and Coloma were closed for over 3 hours March 3 after a car weaving in and out of traffic rear-ended a semi-truck, killing the driver of the car. - 7. *March 4, KSLA 12 Shreveport* (Louisiana) **I-49 in Natchitoches back open after hazmat spill & fire.** HAZMAT crews worked March 4 to clear the site of an overturned semi-truck that was carrying several thousand gallons of flammable, hazardous materials near Natchitoches. The accident prompted closure of a portion of Interstate 49 for more than 2 hours.

- 12. *March 3, KGO 7 San Francisco* (California) **Water main break in Concord leaves big hole in San Miguel Road.** A 36-inch water pipe burst underneath San Miguel Road in Concord, California, March 3, causing authorities to shut down the road for several hours and a large geyser to spray water into the air. - 13. *March 3, Cache Valley Daily* (Utah) **Water boiling order for Trenton residents.** Residents of Trenton, Utah, were placed under a mandatory boil water order that could last a few months after murky colored water was found in the city's drinking system, leading officials to think E. coli, cryptosporidium, giardia, and other bacteria could be contaminating the water.

18. *March 3, Winston-Salem Journal* – (North Carolina) **County employees sent to hospital after chemical spill at jail.** A toxic dry cleaning chemical spilled when a worker removed an unused dry cleaning machine at the county jail in Forsyth County March 3, prompting almost 20 employees to be transported to an area hospital for

20. *March 4, Dark Reading* – (International) **Researchers create legal botnet abusing free cloud service offers.** Researchers presenting at the RSA Conference the week of February 24 demonstrated how they were able to create a botnet by abusing trial accounts for several platform-as-a-service (PaaS) and infrastructure-as-a-service (IaaS) offers. The botnet was created by automating PaaS and IaaS trial sign-up processes and could be used to perform massive port scans, Bitcoin mining, and to manipulate sweepstakes, among other tasks.

- 21. *March 4*, *Help Net Security* (International) **300,000 routers compromised in DNS hijacking campaign.** Researchers with Team Cymru found that around 300,000 small office/home office routers have been compromised and had their DNS settings changed to two IP addresses in the U.K. in order to allow them to perform man-in-the-middle (MitM) attacks. The researchers found that the attack dates to at least mid-December 2013 and has mostly affected routers in Europe and Asia.

- 22. *March 4, Softpedia* (International) **19 security fixes included in latest Chrome 33 update.** Google released an update for its Chrome browser, Chrome version 33.0.1750, which addresses 19 security issues.

23. *March 3*, *Softpedia* – (International) Flaw in Yahoo! Suggestions allowed hackers to delete 1.5 million posts and comments. A security researcher identified and reported an Insecure Direct Object Reference Vulnerability (IDORV) in Yahoo's Suggestions Web site that could have allowed attackers to escalate their privileges and delete large amounts of posts and comments. 24. *March 3, Threatpost* – (International) **Four vulnerabilities found in Oracle Demantra.** Researchers at Portcullis identified four vulnerabilities in Oracle's

Demantra business software that could allow attackers to steal sensitive information, carry out phishing attacks, modify application content, or perform other attacks.

- 25. *March 4, WNYF 28 Watertown* (New York) **Watertown apartment building evacuated.** Residents of the Brighton Apartments building in Watertown were evacuated for several hours March 4 due to carbon monoxide contamination caused by a boiler malfunction at an adjacent building that is under renovation. - 26. *March 3, Royal Oak Daily Tribune* (Michigan) **County HAZMAT, State DEQ** workers investigating massive fuel spill at Auburn Hills business. Crews responded March 3 to an RGIS office building in Auburn Hills after approximately 4,000 gallons of diesel fuel spilled from the business' backup generator and entered a nearby private storm drain that feeds into a retention pond on the property. An environmental clean-up company was hired to handle the spill and investigations are underway to determine if the fuel leaked into the public sanitary system.

Vegas store. Nine people were hospitalized and 17 others were injured after the driver of a pickup truck lost control and crashed through the front of a Food 4 Less grocery store in Las Vegas March 1. The store reopened March 2.
