- 1. *March 11, Traverse City Record-Eagle* (Michigan) **Kingsley oil well erupts in flames.** Authorities are investigating but believe a mechanical problem was likely the cause of a March 9 fire at the Schumde Oil and Gas Company's oil and natural gas well near Kingsley, Michigan, that started when workers began flow tests after completing the well. - 2. *March 11, San Francisco Bay City News; KNTV 11 San Jose* (California) **Sulfuric acid spill at Tesoro Refinery in Martinez.** The California Department of Occupational Safety and Health Administration issued an order shutting down a reactor vessel surrounding pipes at the Tesoro Refinery in Martinez after one worker was injured due to a sulfuric acid spill March 10. Two workers were performing maintenance when the spill occurred.

- 5. *March 10, Wisconsin Rapids Daily Tribune* (Wisconsin) **Juneau County company fined for pollution violations.** Marquis Energy will pay \$125,000 in penalties, fees, and costs after the company failed to obtain air pollutant source construction permits after taking control of a Juneau County, Wisconsin ethanol plant. The Wisconsin Attorney General's Office announced that the plant violated air pollution control laws which included exceeding the maximum production limit in its permit.

The archdiocese advised those affected to check and see if fraudulent tax returns have been filed in their names.

- 11. *March 11*, *Associated Press* (Montana; Wyoming) **Flooding swells Montana rivers, washes out roads.** The Montana governor declared a flood emergency March 9 after warm weather mixed with rain caused snow to melt rapidly and push streams and rivers over their banks, shutting off roads to towns, closing schools, and threatening to overcome protective dykes. National Guard members in Wyoming also worked to stack sandbags and divert flooding from a school and water treatment plant.

24. *March 11*, *Softpedia* – (International) **162,000 WordPress sites abused to amplify DDoS attack.** Researchers at Securi found that attackers used around 162,000 WordPress sites to indirectly launch a distributed denial of service (DDoS) attack on a client's WordPress site by abusing the sites' XML-RPC feature, which is enabled by default on WordPress sites.

- 25. *March 11*, *Threatpost* (International) **Apple iOS 7.1 fixes more than 20 code-execution flaws.** Apple released an update for its iOS mobile operating system, closing several code execution vulnerabilities and other issues. 27. *March 10, IDG News Service* – (International) **Joomla receives patches for zero-day SQL injection vulnerability, other flaws.** The Joomla Project released security updates for its Joomla content management system, addressing a SQL injection vulnerability that could be used to steal information from databases on Joomla-based Web sites, as well as addressing two cross-site scripting (XSS) vulnerabilities and an unauthorized log-in flaw.

28. *March 11, Fox News* – (Texas) **Church robbed of \$600G in cash, checks.** Officials from Lakewood Church in Houston announced that thieves stole \$600,000 in cash, check, and credit card donations from a safe at the church between March 9-10. The theft was limited to contributions made during March 8-9 services and was not an electronic data breach.

29. *March 11*, *El Paso Times* – (Texas) **Fire officials evacuate and shutdown Gateway Hotel in downtown El Paso.** The Gateway Hotel in El Paso was evacuated and shut down indefinitely March 10 after an investigation revealed water damage to the structure, a faulty sprinkler system, defective fire exits, and plumbing and electrical issues. At least 37 long and short-term residents were displaced by the eviction after the building was deemed to be a hazard.
