Top Stories

- A severe winter storm dumped heavy snow and brought high winds in the Midwest and Northeast March 12, wreaking havoc on the regions. *Associated Press* (See item 1)
- More than 4,000 people in Long Island, New York, were alerted March 11 that they could have been infected with HIV while being treated for diabetes. WCBS 2 New York City (See item 16)
- Two people were killed and 23 others were injured after a motorist fleeing from police plowed through barricades and into a crowd in front of a nightclub at the South by Southwest festival in Austin, Texas, March 13. *Associated Press* (See item 31)

1. *March 13, Associated Press* – (National) **Northeast digs out from late winter storm.** A severe winter storm dumped heavy snow and brought high winds in the Midwest and Northeast March 12, causing tens of thousands of homes and businesses to lose power, hundreds of flight cancellations, and a pileup involving at least 50 vehicles on the Ohio Turnpike that left 3 people dead.

The Fergus Falls fire chief reported March 12 that a mechanical failure caused a fire and explosion March 10 at the Green Plains Renewable Energy ethanol plant in Minnesota. 3. *March 12*, *Charleston Gazette* – (West Virginia) **DEP: Freedom in compliance with demolition schedule.** The West Virginia Department of Environmental Protection released Freedom Industries' plan March 12 detailing how the company will dismantle and remove chemical storage tanks from its Elk River facility. The company agreed to begin demolishing the site March 15 after a January chemical spill that contaminated the water supply of 300,000 West Virginia residents.

4. *March 12*, *SpaceNews* – (National) **Bad soldering pushes 3rd MUOS satellite toward end of the launch queue.** Lockheed Martin and Boeing Space and Intelligence Systems officials stated March 12 that a soldering problem with a payload was discovered during testing and has delayed completion of the third satellite in the U.S. Navy's Mobile User Objective System satellite communications system. The satellite was pulled from the assembly line, and production of a fourth satellite has been expedited to maintain the current launch schedule.

- 5. *March 13*, *Softpedia* (International) **PayPal rewards researcher for finding EL injection vulnerability in Zong.** A researcher identified and reported an Expression Language (EL) vulnerability in mobile payments processor Zong which could be used for code execution and other tasks. 8. *March 13*, *Newark Star Ledger; Associated Press* – (New Jersey) **Tanker crash delays trains in New Jersey.** Route 21 in Newark was closed for an unspecified amount of time after a semi-truck traveling parallel to an Amtrak rail line on McCarter Highway in Newark while carrying 8,500 gallons of fuel burst into flames March 13 after colliding with a car. No injuries were reported but Amtrak trains experienced a roughly

45 minute delay.

9. *March 12, Hillsboro Times Gazette* – (Ohio) **Highway, rail line reopened after gas leak forces closure.** State Road 28 and a railroad line in East Monroe, Ohio, were closed for at least 4 hours after a 1,000 gallon propane tank leaked and caused a dense black cloud to hover over the road March 12.

15. March 12, Pittsburgh Tribune-Review – (Pennsylvania) Security breach compromises credit-card info at Bloomfield medical practice. Partners in Nephrology & Endocrinology in Pittsburgh confirmed March 12 that an attacker hacked into a vendor's system that processes credit card payments for the practice and potentially accessed credit card numbers and personal information of about 5,000 patients in November 2013. Authorities are investigating the incident.

16. *March 11*, *WCBS 2 New York City* – (New York) **L.I. hospital: Reused insulin pen part may mean hepatitis, HIV risk for patients.** South Nassau Communities Hospital in Oceanside, New York, recommended more than 4,000 patients get tested for hepatitis B, hepatitis C, and HIV after it learned that patients being treated for diabetes may have received insulin injections from a pen reservoir that may have been used on more than one patient. The hospital has since banned the use of insulin pens and now only permits single-patient-use vials.

Officials reported that the problem remains unresolved but they are working to fix the issue.

The suspect was allegedly intoxicated and taken into custody at the scene.

33. *March 13*, *New Jersey Herald* – (New Jersey) **High winds rip off roof of Mount Olive store.** A Bed Bath & Beyond store in Mount Olive closed indefinitely for repairs March 13 after high winds blew off part of the store's roof and caused a gas line to rupture, sparking a small fire in an air conditioning system. A nearby store was temporarily closed while gas service in the area was shut off.

34. *March 13*, *WUSA 9 Washington*, *D.C.* – (Virginia) **Alexandria apt. building condemned after wall collapse.** A partial wall collapse at an Alexandria, Virginia apartment complex forced residents from 19 units to evacuate and prompted officials to condemn the building March 13. Estimated damage to the building was approximately \$150,000.

35. *March 12, Fort Lauderdale Sun-Sentinel* – (Florida) **Broward man used bomb** threats to try to extort \$50 million from Publix, feds say. A Florida man was charged March 12 after sending emailed bomb threats to Publix company officials between January 2013 and March 2013 in an effort to extort up to \$50 million from the supermarket chain. Officials believe the suspect is connected to a pipe bomb that detonated at a Publix store in Dania Beach in May 2013, which may have been planted months earlier.

The entire facility underwent a thorough cleaning before reopening.

- 37. *March 12, Imperial Valley Press* (California) **Water release may revive Colorado River Delta.** U.S. and Mexican officials will release more than 105,000 acre-feet of water over an 8 week period in a "pulse-flow" through the Morelos dam beginning March 23 in an attempt to replenish the Colorado River Delta.
