### **Top Stories**

- North Carolina officials announced March 20 that Duke Energy illegally pumped 61 million gallons of contaminated water from its Cape Fear Plant into the Cape Fear River over the course of several months. *Associated Press* (See item 1)
- Tonawanda Coke Corp., in New York was fined \$12.5 million and its former environmental manager was sentenced to 1 year in jail March 19 for knowingly releasing hundreds of tons of benzene into the air and improperly handling hazardous sludge. *Associated Press* (See item 3)
- The Internal Revenue Service (IRS) inspector general stated March 20 that over 200,000 individuals have been targeted by the largest phone scam the agency has seen, with over \$1 million stolen by callers claiming to be IRS agents. *Associated Press* (See item 7)
- Authorities are investigating the cause of a March 21 fire at the Mariner's Cove Motor Inn in Point Pleasant Beach, New Jersey, which killed 3 people and injured 8 others, with 10 people remaining unaccounted for. Newark Star-Ledger (See item 24)

- 1. *March 20, Associated Press* (North Carolina) **Regulators say Duke pumped coal ash into NC river.** The North Carolina Department of Environment and Natural Resources announced March 20 that Duke Energy illegally pumped 61 million gallons of contaminated water from its Cape Fear Plant into the Cape Fear River over the course of several months, and issued the utility a formal notice of violation. - 2. March 20, Dickinson Press (North Dakota) Crews cleaning up pipeline oil spill that leaked 400 barrels. A leak believed to have originated from the seal in a joint of a pipeline at a Hiland Crude LLC facility in McKenzie County released an estimated 16,800 gallons of crude oil March 20, an official with the Division of Water Quality for the North Dakota Department of Health stated. The spill was controlled and crews worked to remove the contaminated soil.

- 3. March 19, Associated Press (New York) Coal-burning NY coke plant fined \$12.5M for Clean Air Act violations; manager gets jail, fine. Tonawanda Coke Corp., was fined \$12.5 million and its former environmental manager was sentenced to 1 year in jail March 19 for knowingly releasing hundreds of tons of carcinogen benzene into the air between 2005 and 2009 and improperly handling hazardous sludge on the ground at its New York plant.

announced March 20 that it would send radioactive refuse to the Waste Control Specialists facility in Andrews County, Texas, temporarily while the Waste Isolation Pilot Plant near Carlsbad, New Mexico, remains closed after a radiation leak at the facility.

6. *March* 20, *Associated Press* – (Pennsylvania) **Pa. reactor shut down for valve leak.** The Unit 2 reactor at the Susquehanna nuclear power plant near Berwick was shut down March 20 after a leaking water valve was discovered as the reactor was being brought back online after a planned outage.

7. *March 21, Associated Press* – (National) **Fake IRS agent scam bilks taxpayers of \$1 million.** The inspector general of the Internal Revenue Service (IRS) stated March 20 that over 200,000 individuals have been targeted by the largest phone scam the agency has seen, with over \$1 million stolen by callers claiming to be IRS agents. The criminals behind the scam obscure caller ID indicators to make it appear as if they are calling from a legitimate number, and in some cases know the last four digits of targets' Social Security numbers.

8. *March 20, Clarion Ledger* – (National) **Biloxi attorney pleads guilty to Ponzi-type fraud scheme.** A Biloxi, Mississippi attorney pleaded guilty March 20 to running a Ponzi-like scheme though two companies with offices in several States that he used to commingle trust accounts with personal and business accounts and then divert and obscure the diversion of funds between accounts for his own personal use. Prosecutors are seeking more than \$7.7 million in restitution for victims.

BlackOS started being advertised on underweb forums in February and is based on the "Tale of the North" software. 24. *March* 21, *Newark Star-Ledger* – (New Jersey) **Point Pleasant Beach motel fire kills** 3, injures 8. Authorities are investigating the cause of a March 21 fire at the Mariner's Cove Motor Inn in Point Pleasant Beach, which killed three people and injured eight others. About 40 guests were staying at the hotel at the time of the blaze, and officials are searching for 10 people who remained unaccounted for.

25. *March 20, Washington Post* – (Virginia) **Alexandria woman, 73, linked to 25** apartment house fires. A resident of the Southern Towers Apartment complex in Alexandria, Virginia, was arrested and charged March 19 after security footage linked the woman to setting a fire in a trash room March 18. The suspect later admitted to setting 25 fires in the building since May 2013, causing repeated evacuations and about \$55,000 in damage.

26. *March* 20, *Atlanta Journal-Constitution* – (Georgia) **Hotel evacuation ends with 4 arrests.** Guests of a Holiday Inn in Dekalb County were forced to evacuate for several hours after police responded to a report of possible drug activity inside a hotel room and found an explosive device during their search. Police cleared the hotel and arrested four suspects found in possession of drugs and weapons and believed to be connected to a string of crimes.

27. *March 20, Wilmington News Journal* – (Delaware) **Officials clear Wilmington building to remove hazardous material.** HAZMAT crews responded to the Cynwood Apartments in Wilmington, Delaware, March 18 after a refrigeration unit leaked coolant gas and filled the building with a chemical odor. Residents were evacuated and cannot return until HAZMAT crews seal the leak and safely remove the unit from the building.
