#### **Top Stories**

- Blue line rail service was suspended March 24 after a Chicago Transit Authority train continued through the end of the platform and struck the escalators leading to the terminals at O'Hare International Airport, leaving 32 people injured.— WMAQ 5 Chicago (See item 7)
- Authorities closed the Houston Ship Channel indefinitely after nearly 170,000 gallons of tar-like oil spilled into the Texas waterway when a barge collided with a ship March 22. *Associated Press* (See item 8)

- 1. *March 23, Cincinnati Enquirer* (Ohio) **Nearly 32K gallons of liquid removed in** Colerain oil spill. Crews had removed 31,600 gallons of an oil-water mixture from the Hamilton County-owned Oak Glen Nature Preserve by March 23 while investigators continued to assess what caused an interstate pipeline to burst March 17 and leak about 15,000 gallons of oil in the Colerain Township nature preserve.

The California Public Utilities Commission reported March 20 that Southern California Edison agreed to pay a \$24.5 million penalty for safety violations found after a November 2011 windstorm left 440,000 customers without electricity and a power-line failure electrocuted 3 family members. Regulators stated that the utility gave inaccurate information on power restoration and violated safety standards during the storm.

Authorities are investigating the cause of the accident. Crews worked to place approximately 60,000 feet of containment booms around the

area during cleanup efforts.

9. March 24, Reuters – (Washington) Over 100 missing-persons reports filed in Washington mudslide. A March 22 landslide in Washington left 8 people dead and at least 100 others reported missing after homes and cars were covered in debris up to 15 feet deep. The landslide was triggered by rain-soaked embankments which prompted the indefinite closure of State Route 530 in both directions.

10. *March 24, Grand Junction Daily Sentinel* – (Colorado) **Plane, 5 bodies submerged in Ridgway Reservoir.** Ouray County officials reported that the location of a single-engine airplane that crashed March 22 into Ridgway Reservoir in Colorado after taking off from Oklahoma was confirmed March 23 through divers and sonar images. Recovery operations were underway on locating the plane and the bodies of its five passengers.

25. *March* 20, *Threatpost* – (International) **Weakness in Android update service puts all devices at risk for privilege escalation.** Researchers at Indiana University and Microsoft published a paper that found that the Package Management Service (PMS) for Android can create vulnerabilities dubbed Pileup flaws by improperly vetting requests for operating system or app privileges after an update, automatically granting privileges that did not exist in older versions of Android. The researchers stated that vulnerabilities exist on all Android Open Source Project versions and on many customized versions, impacting over one billion Android devices.

FEMA will also award the city \$56 million to cover expenses that were accrued during the installation of temporary boiler systems.
