1. *March 27, Lexington Herald-Leader* – (Kentucky) **50 citations were issued to three Kentucky mines in February.** The U.S. Mine Safety and Health Administration reported March 27 that federal inspectors issued a total of 50 citations to Nally & Hamilton Enterprises, Armstrong Coal Company, and Redhawk Mining LLC, for alleged health and safety violations found during February inspections at their mines in Kentucky.

2. *March 28, KSHB 41 Kansas City* – (Missouri) **Anhydrous ammonia leak in Platte Co. capped.** A broken valve on an 800-gallon tank located in a Platte County field caused anhydrous ammonia to leak for nearly 1 hour March 28 before crews were able to cap the valve. Nearby roadways were closed and evacuations were recommended for those within a half-mile radius of the tank during the incident.

- 3. *March 31*, *Softpedia* (International) **Hackers can unlock Tesla cars by stealing owners' passwords.** A security researcher reported that the password created by Tesla car owners can be easily obtained via brute force attacks due to it only containing six letters and numbers, allowing attackers to track the location of Tesla cars or unlock the door locks remotely. The remote management API also may share credentials with untrusted third parties that could also lead to security issues.

The recall expansion covers several Chevrolet, Pontiac, and Saturn vehicles from model years 2003-2007 that may have had defective ignition parts installed during repairs.

The fraud occurred through Mutual Benefits Corporation, which deceived around 30,000 investors to obtain the money between 1994 and 2004.

Embers from a bee pot smoker ignited straw chaff and a fire spread throughout a barn in Eleva, causing the structure collapse March 30. One worker suffered minor injuries and authorities estimated the damage to total \$200,000.

Several requirements must be met before Jensen's can resume operations.

Fandango and Credit Karma agreed to a settlement with the Federal Trade Commission (FTC) after the FTC charged that both companies deliberately misrepresented the security of their mobile apps and created apps that failed to validate SSL certificates. The companies are required by the settlement to submit to independent security audits for the next 20 years and to create comprehensive security programs.

30. *March 31*, *Omaha World-Herald* – (Wyoming) **FCC imposes \$17,000 fine on owner of mysterious radio station KOMJ.** The U.S. Federal Communications Commission ordered Wyoming-based Cochise Broadcasting, owner of KOMJ 1490 AM Omaha, to pay a \$17,000 fine for failing to operate and staff a main studio with a public inspection file for the station.

Emergency service was restored after about 11 hours and Pittsfield Communications crews worked to install a portable tower and transmitters in an effort to restore service by the end of March 31.
