- 5. April 8, Bloomberg News (International) U.S. seeks to seize \$12 million in Swisslinked tax case. U.S. federal prosecutors filed a forfeiture action April 8 against an unidentified individual and the individual's father, seeking to seize \$12.2 million held in two unidentified Swiss banks due to an alleged mail and wire fraud scheme that sought to defraud the Internal Revenue Service of due taxes. The accounts were allegedly set up by a Swiss attorney who previously pleaded guilty to committing tax fraud for more than a decade.

- 7. April 8, Philadelphia Business Journal (Pennsylvania) General contractor pleads guilty in \$20M mortgage loan scheme. A general contractor pleaded guilty April 8 to working with co-conspirators to defraud banks and the Federal Housing Administration by inflating purchase prices on mortgage documents for over 100 Philadelphia properties between 2004 and 2009, resulting in over \$20 million in fraudulent proceeds. The case also involves other defendants associated with the KREW Settlement Services company that allegedly ran the scheme.

The restaurant was professionally sanitized and met requirements set forth by the department before it reopened April 7, following a voluntary closure April 1.

The U.S. Food and Drug Administration announced April 8 that Buffalo SAV Inc., recalled 2 pound packages of its Grandma's brand Potato and Bacon perogies products due to undeclared soy protein.

A report from the U.S. Centers for Disease Control and Prevention stated that a 2013 Listeria outbreak connected to cheeses from Wisconsin-based Crave Brothers Farmstead Cheese Co., which caused one death and several illnesses, was likely caused by substantial sanitation deficiencies during the cheese-making process. Three of the company's cheese products were recalled as a result of the outbreak.

All affected patients were notified and the doctor's group has since eliminated use of outside physician email accounts in their domain.

The school is removing the wood chips and washing down surfaces that may have been exposed while they continue to investigate where the peppers originated from.

Authorities are investigating the cause of an April 8 fire that broke out at the Coral Ridge Towers apartment building in Fort Lauderdale and prompted the evacuation of more than 100 residents. Two individuals were transported to an area hospital for treatment.

Authorities are searching for the cause of the fire and are investigating if construction activity may have sparked the blaze.

39. *April 8, Palm Springs Desert Sun* – (California) **Coachella daycare evacuated due to gas leak.** A construction worker inadvertently struck a gas line and caused a leak April 8, prompting the evacuation of 23 children and 11 adults from a daycare center, as well as 2 nearby businesses in Coachella. Gas service was cut off to at least 3 apartment

complexes and several homes while crews worked to contain the leak.

40. *April 8, WJLA 7 Washington, D.C.* – (Maryland) **Hazmat teams evacuate Bethesda office building due to freon leak.** Hundreds of employees and visitors were evacuated from the Two Democracy Center office building in Bethesda April 8 due to a reported freon leak. Officials investigated the cause of the incident while crews worked to control the leak and ventilate the building.

Crews cleared the scene after about 5 hours and the store was scheduled to reopen April 9.
