- 1. *April 14, WDIV 4 Detroit* (Michigan) **DTE: 100,000 customers without power.**DTE Energy crews worked to restore power to 100,000 customers around Detroit April 14 after an April 12 storm produced strong winds and knocked out electricity.

- 2. April 12, Clarksburg Exponent Telegram (West Virginia) Antero Resources shuts down well pad after water tanks rupture. A pair of water production tanks ruptured April 11, prompting Antero Resources to shut down its Marsden well pad in the Town of West Union in West Virginia. Authorities reported that the spill was fully contained and the cause of the rupture is under investigation.

- 3. *April 12, Forum of Fargo-Moorhead* (North Dakota) **560-barrel pipeline leak reported south of Medora.** Continental Resources reported that a pipeline leaked about 560 barrels of production fluid near Medora into dry drainage, with some reaching flowing drainage. Approximately 100 barrels were recovered April 12 while inspectors remained on site to test the water and soil.

- 4. *April 12, KSAT 12 San Antonio* (Texas) **Fuel from south-side refinery spills into S.A. River.** About 1,100 gallons of fuel spilled April 11 when a Calumet-owned refinery plant in San Antonio was transferring jet fuel to a rail truck. Authorities reported that less than 100 gallons of the spilled fuel leaked into the San Antonio River April 12.

The roadway was closed for nearly an hour and two nearby homes were evacuated as a precaution while crews worked to clean the spill. The U.S. Department of Justice unsealed an indictment against nine individuals for allegedly being involved in a criminal organization that used the Zeus banking trojan to steal millions of dollars. The alleged scheme used Zeus to steal account information and then transfer stolen money to accounts belonging to 'mules' who withdrew and transferred the money.

One passenger was killed and two others were hospitalized after a small plane crashed April 12 while the pilot was attempting an emergency landing in Denton due to a mechanical failure. High winds caused the single-engine aircraft to crash near the airport.

- 13. *April 13*, *CNN* (International) **Cruise ship passengers sickened on luxury liners.** The U.S. Centers for Disease Control and Prevention is investigating after Royal Caribbean's Grandeur of the Seas had two back-to-back outbreaks of illness, primarily with vomiting and diarrhea, affecting more than 100 people in both instances in April. A third outbreak affected Princess Cruise's Crown Princess during its week-long cruise ending April 12 impacting 152 passengers and crew.
