#### **Top Stories**

- The head of the Idaho-based DBSI Inc., real estate investment firm and three others were found guilty April 14 on federal wire and securities fraud charges over a scheme which cost investors at least \$169 million. *Minneapolis Star Tribune* (See item <u>6</u>)

1. *April 15, WNEP 16 Scranton* – (Pennsylvania) **Power plant set to shut down.** Officials announced April 14 that a Sunbury Generation electricity generating plant in Snyder County is scheduled to close in June due to new environmental regulations going into effect in 2015.

2. April 14, Winston-Salem Journal – (North Carolina) One taken to hospital after explosion in downtown Winston-Salem lab. One employee of Asinex was injured by a small chemical explosion caused by mixing sodium azide with a trade chemical during a routine procedure inside a laboratory in the Wake Forest Innovation Quarter in Winston-Salem April 14. The building was evacuated and nearby roadways were closed for several hours while HAZMAT crews assessed and cleared the scene. 3. *April 15, Newark Star-Ledger* – (New Jersey) **Ex-Picatinny worker accused of endangering kids with radioactive material.** A former contractor at the Picatinny Arsenal was arrested at his home in Sparta, New Jersey, April 12 and charged with endangering his children when police responding to an unrelated issue spotted three small canisters containing radioactive materials. Police suspected that the materials were stolen from the Picatinny Arsenal.

A security researcher identified and reported a cross-site scripting (XSS) issue and an information disclosure issue that could be leveraged for remote code execution in the PayPal Partner Program's payment processor Web site. The issues were later closed by PayPal.

8. April 15, WDJT 58 Milwaukee – (Wisconsin) Multiple cars slide into semi near Miller Park, dozens of other crashes Monday into Tuesday. Northbound lanes of U.S. 45 in Wauwatosa were closed for 5 hours April 14 while police responded to several multi-vehicle accidents, including an accident involving 2 semi-trucks and 2 school buses. All lanes of Interstate 94 in Waukesha County were also closed for 2 hours due to blowing snow and icy conditions that caused a crash involving 7 vehicles. 9. April 14, Federal Aviation Administration – (National) FAA proposes \$547,500 civil penalty against Hawaiian Airlines. The U.S. Department of Transportation's Federal Aviation Administration (FAA) proposed a \$547,500 penalty against Hawaiian Airlines Inc., April 14, declaring the airline was not in compliance with a July 2000 Airworthiness Directive (AD) requiring inspection of certain engine thrust reverser components. The FAA alleged the airline operated a Boeing 767-300 more than 5,000 times between July 2004 and July 2012 when it was out of compliance.

Authorities believe a malfunctioning soda carbonation machine may be to blame for a carbon dioxide leak at Rooster's Barn and Grill in Rochester, Minnesota, April 14. One employee was hospitalized after he collapsed while investigating the leak in the basement of the restaurant. - 11. April 14, U.S. Department of Agriculture (International) Washington firm recalls dried egg products due to possible Salmonella contamination. The Food Safety and Inspection Service (FSIS) announced April 14 that Nutriom LLC expanded its February 15 recall of 226,710 pounds of processed egg products to include an additional 82,884 pounds of the products due to possible Salmonella contamination. The FSIS issued a public health alert March 26 removing the products from commerce after the company declined to expand its initial recall, and Nutriom later agreed to a partial recall of some products identified in the alert.

- 12. April 13, Food Safety News (Michigan) Clostridium perfringens apparent cause of Michigan outbreak. Preliminary results announced by the Muskegon County Department of Health revealed a presence of Clostridum perfringens, a foodborne illness-causing bacteria, in a sample tested from Bonicki's Restaurant and Sports Bistro. Officials engaged following at least six reports from customers who were sickened after eating at the restaurant between April 3 and April 6.

- 13. April 12, Food Poisoning Bulletin (California) California warns consumers not to eat anchovies, sardines, crab. California health officials warned consumers to avoid eating commercially or recreationally caught anchovies or sardines or the internal

organs of crab from Monterey and Santa Cruz counties due to dangerous levels of domoic acid found in the species. This warning is in addition to an April 4 advisory that warned against eating recreationally harvested bivalve shellfish, such as mussels and clams, from the same counties for the same reason.

- 14. April 12, U.S. Food and Drug Administration (National) Private Selection Sweet Strawberry Sorbet recalled for undeclared allergen. The Kroger Co., announced a recall of 16-ounce packages of its Private Selection Sweet Strawberry Sorbet sold at Kroger and Jay C stores in 13 States due to undeclared milk. The recall was initiated after two consumers reported possible allergic reactions in connection with the product. SINCO Inc., voluntarily recalled its 30-ounce packages of Archer Famers Chocolate Hazelnut Swirl Gelato due to undeclared peanut protein. ### **Healthcare and Public Health Sector**

17. April 15, Bryan-College Station Eagle – (Texas) Former chiropractor, co-defendant sentenced in insurance fraud scheme. A former Bryan, Texas chiropractor and a co-defendant were among five people convicted for their roles in a scheme to submit \$3 million worth of false billing claims, of which insurance companies paid at least \$1.2 million. Four chiropractic clinics and a law firm were used in the scam to recommend patients who had allegedly been injured in auto accidents to receive unnecessary treatment in order to falsely bill the auto insurance companies and force them into settling claims.

24. *April 15, Softpedia* – (International) **Expert finds SQL injection, RCE vulnerabilities in Flickr Photo Books.** A security researcher identified and reported a SQL injection vulnerability and a remote code execution vulnerability in Flickr's Photo Books Web site that could allow an attacker to gain access to Flickr's databases. Yahoo closed the vulnerabilities after a second report by the researcher.

Computer storage manufacturer LaCie stated that the FBI informed the company of a data breach where malware was used to gain access to customer transactions carried out on the company's Web site. LaCie temporarily disabled the e-commerce portion of its Web site and will be resetting users' passwords in response.

27. *April 14, Softpedia* – (International) **Flash SMS flaw in iOS can be exploited to make the lock screen unresponsive.** A security researcher identified a Flash SMS flaw in iOS that can be used to make a device's lock screen unresponsive, which could be used for ransom attacks. The flaw was fixed with the release of iOS 7.1 but devices running previous versions of the mobile operating system are vulnerable.

Three floors of the building were evacuated as a precaution when police believed they saw and smelled gasoline outside the apartment, and nearby roadways were closed during the incident.

One person was injured by the blaze, and 36 units in the buildings were destroyed, leaving more than 50 residents displaced.
