- 2. April 26, Hawaii24/7.com (Hawaii) Sulfuric acid spill temporarily closes street in Hilo Friday morning (April 25). Crews responded when about 250 gallons of sulfuric acid spilled from a container as it was being loaded onto a truck at BEI Hawaii in Hilo April 25. Workers used soda ash to neutralize the acid, some of which leaked into a roadway drywell, while authorities tested pH levels and cleaned the area. - 3. April 25, Reno Gazette-Journal (Nevada) 1 dead in Sparks Sierra Chemical air canister explosion. No other chemicals or fire were involved in the explosion and operations were suspended indefinitely while authorities investigated the incident.

Summer nuclear power plant in Jenkinsville will be replaced in 2017 after small cracks were found in the current reactor vessel head during a planned maintenance outage. 5. April 29, Associated Press – (National) BMW recalls 156,000 cars, SUVs due to stalling engines, increased crash risk. BMW announced a recall of over 156,000 model year 2010-2012 1-Series, 3-Series, 5-Series, 6-Series, X-Series, and Z4 vehicles due to the potential for bolts holding a camshaft housing to loosen and break, leading to reduced power or stalling.

7. April 29, U.S. Consumer Product Safety Commission – (National) GE Brand Dehumidifiers by Midea recalled for repair due to fire hazard; sold exclusively at Walmart. Midea announced a recall of around 15,500 GE Brand Dehumidifiers due to the potential for a component in the dehumidifiers' compressors to short circuit, posing a fire hazard. The dehumidifiers were sold exclusively at Walmart stores between March 2010 and December 2010.

April 29, U.S. Consumer Product Safety Commission — (National) **DGL Group recalls Vibe USB Mobile Power Bars due to fire hazard; sold exclusively at Five Below.**DGL Group announced a recall of around 99,000 Vibe USB Mobile Power Bars that were sold exclusively at Five Below stores due to the potential for the devices to overheat, posing a fire hazard.

A Sacramento real estate agent pleaded guilty April 28 to running the scheme.

The Marion County Public Health Department issued an alert April 28 warning that patrons who visited the Teavana store at the Fashion Mall at Keystone shopping center April 5, 12, and 19 may have been exposed to hepatitis A. Officials advised individuals who visited the store and drank tea April 19 to receive a vaccination or immune globulin to prevent the disease, while patrons who visited April 5 and 12 are beyond the incubation period of the virus and should monitor for symptoms.

18. *April 28*, *WPXI 11 Pittsburgh* – (Pennsylvania) **DEP issues recall for locally bottled water with E. coli bacteria.** The Pennsylvania Department of Environmental Protection issued a recall during the weekend of April 26 for 9,400 units of 3-, 4-, and 5-gallon bottles of Tyler Mountain Water, which is bottled and delivered by Pennsylvania-based Aqua Filter Fresh. The recall was initiated after tests by the Allegheny County Health Department revealed total coliform and E. coli bacteria in samples.

19. *April 27, Associated Press* – (New York) **Teen's arm severed in NY eatery's pasta machine.** An employee of Violi's Restaurant in Massena was cleaning the store's pasta machine when his right arm got caught and severed at the elbow April 24. Authorities

are investigating what triggered the machine to activate while the employee was cleaning it.

21. April 29, Associated Press – (Kentucky) Wastewater release in Bullitt County prompts warnings against contact with streams. A system failure at the Hunters Hollow Wastewater Treatment Plant in Bullitt County caused untreated wastewater high in E. coli to be leaked into a tributary of Brooks Run and the mainstem of Brooks Run below the tributary. Officials posted signs advising people to avoid recreational use of the water.

22. *April* 28, *Laguna Beach Coastline Pilot* – (California) **Sewage spill closes portion of coastline.** A blocked sewage line April 28 caused a sewage leak out of a manhole at a Laguna Hills intersection, allowing about 10,000 gallons to flow into storm drains and prompting the Orange County Health Care Agency to close a half-mile stretch of coastline near Aliso Beach Park.

Authorities arrested one man while the other is still on the loose and considered a fugitive.

30. *April 29, Help Net Security* – (International) **AOL breach confirmed, bigger than initially thought.** AOL confirmed April 28 that attackers breached the company's systems and networks, leading to a significant increase in spoofed email spam from AOL Mail accounts. Around 500,000 users had their email addresses, postal addresses, address book contacts, encrypted passwords, and encrypted security questions compromised in the breach.

31. *April 29, Softpedia* – (International) **Siemens patches Heartbleed bug in industrial products.** Siemens published an advisory and updates for several of its industrial control systems (ICS) programs that address the Heartbleed vulnerability in OpenSSL. Some Siemens ICS software remain unpatched, and the company advised users to apply workarounds until a full patch is made available.

- 32. *April* 29, *Softpedia* (International) **Apple fixes vulnerability that granted anyone access to personal details of developers.** Apple closed a vulnerability in its Developer Center's Radar application that could have been exploited to obtain the contact information of Apple retail and corporate employees and iOS, Mac, and Safari developers. A proof-of-concept was revealed by the researcher who discovered the vulnerability after Apple closed the vulnerability.

The researchers identified several Azure-hosted phishing pages targeting Apple, Comcast, PayPal, Visa, American Express, and Cielo customers.

The U.S. Computer Emergency Readiness Team (US-CERT) advised users to stop using the Internet Explorer browser until Microsoft can develop a patch for a recently-disclosed vulnerability that can allow attackers to run malicious code. The vulnerability is currently being used in attacks against U.S. defense and financial organizations, according to FireEye researchers.
