Top Stories

- Nearly 400 miles of Interstate 80 between Wyoming and Colorado was shut down for about 24 hours after a winter storm dumped up to 3 feet of snow May 12 causing a fatal accident on U.S. Highway 285 near Denver. NBC News; Associated Press (See item 13)
- Heavy rains May 11 overwhelmed the a stormwater system in Calumet City, Illinois, building up pressure in a sewer tunnel and causing an underground hydraulic explosion that created a sink hole. The storm also caused streets to flood, knocked out power for thousands, and canceled more than 130 flights. *WBBM 2 Chicago* (See item 19)
- A Canadian teenager was arrested May 8 by the Ottawa Police Service in connection with placing four false emergency calls from April to May to Melbourne High School in Florida, prompting a 3-hour lock down during one call. USA Today (See item 23)
- Several downtown San Antonio hotels and businesses, including the Grand Hyatt Hotel at the Convention Center, were without water May 13 due to a water main break. – KABB 29 San Antonio (See item <u>25</u>)

A preliminary report from the Mine Safety and Health Administration blamed a ground failure for the incident while an initial report from the West Virginia Office of Miners' Health, Safety, and Training blamed a coal outburst.

- 3. *May 13, Morristown Daily Record* (New Jersey) **East Hanover gas station pays \$26,000 fine for post-Sandy price gouging.** The New Jersey Division of Consumer Affairs announced May 12 that East Hanover Amoco, doing business as C&M Exxon, will pay a \$26,000 fine for raising its prices in the aftermath of superstorm Sandy. The division also settled with two hotels accused of price gouging by allegedly raising room rates after superstorm Sandy.

- 4. *May 12*, *Associated Press* (Kentucky) **Patriot idles Kentucky mine complex for repairs.** Patriot Coal Corp. announced May 12 that its Highland Mine complex in Henderson will be idle while repairs are made to a preparation plant that was damaged May 6 due to a structural failure. - 5. May 12, Forum of Fargo-Moorhead (North Dakota) Workers trying to secure out-of-control oil well near Tioga. Crews worked to secure the Emerald Oil-owned Ron Burgundy 3-23-14H well near Tioga, North Dakota, May 12 after losing control of the well May 9 causing an unknown amount of oil, gas, and water to discharge. Officials are assessing volume estimates on the fluids released and reported workers stabilized the well and contained the liquids.

6. *May 12*, *U.S. Environmental Protection Agency* – (Utah) **EPA requires Chevron Pipe Line to provide funding for oil spill response.** Chevron Pipe Line Company agreed to pay \$875,000 May 12 in a settlement with the U.S. Environmental Protection Agency to resolve Clean Water Act violations associated with two spills at the company's Utah facilities. A June 2010 spill discharged roughly 800 barrels of oil into Red Butte Creek and a March 2013 spill discharged approximately 499 barrels of diesel fuel into wetlands near Willard Bay.

8. May 13, U.S. Consumer Product Safety Commission – (National) Paramount recalls Trident Ultraviolet Sanitation Systems for pools due to fire hazard. Paramount Leisure Industries, also known as Paramount Pool and Spa Systems, recalled about 960 units of its Paramount Trident Series 2 (UV II) ultraviolet sanitation systems sold at pool companies from September 2013 through January 2014 due to the electrical arching which can cause the units to catch fire. The product was manufactured in the United States and China.

9. *May 12, U.S. Department of Labor* – (Georgia) **Truck parts manufacturer cited for serious safety violations following inspection by US Department of Labor's OSHA; \$64,400 in fines proposed.** Blue Ridge Manufacturing LLC was fined \$64,400 by the Occupational Safety and Health Administration for 20 safety and health violations, including hazards such as unguarded equipment, missing safety equipment, and unsafe noise levels, at the company's truck body manufacturing facility in Blue Ridge.

- 10. May 12, U.S. Securities and Exchange Commission (California; Minnesota) Three software company founders to pay \$5.8 million to settle charges of insider trading ahead of sale. Three software company founders agreed to pay nearly \$5.8 million May 12 to settle charges filed by the U.S. Securities and Exchange Commission accusing the individuals of taking advantage of incorrect media speculation and analyst reports regarding the company's, Lawson Software, acquisition. The commission reported the Lawson Software's co-chairman informed two others with nonpublic information about the status of the company's 2011 merger discussion with Infor Global Solutions, while stock prices grew based on inaccurate media speculation. - 11. *May 12, KPRC 2 Houston* (Texas) California man pleads guilty to Houston credit card skimming. One member of a group made up of at least five individuals from Texas to California pleaded guilty May 12 to charges after being arrested in 2011 in connection to a credit card skimming ring that netted 38,000 credit card numbers from gas stations in the Houston and Dallas area.

13. *May 13, NBC News; Associated Press* – (National) **400 miles of Wyoming highway shut down after spring snow storm.** Nearly 400 miles of Interstate 80 between Wyoming and Colorado was shut down for about 24 hours after a winter storm dumped up to 3 feet of snow May 12 causing a fatal accident on U.S. Highway 285 near Denver.

No one was injured and crews expected cleanup to be completed by May 14.

- 15. *May 13*, *Twin Falls Times-News* (Idaho) **Jerome dairy processor fined \$170K by EPA.** The U.S Environmental Protection Agency announced May 12 that Idaho Milk Products of Jerome, Idaho, agreed to pay a \$170,000 in fines for failing to meet Clean Water Act standards for acidity by pumping wastewater into the city's sewer system that exceeded its acidity limit 138 times between March 2009 and July 2012. No damage to the city's wastewater infrastructure was reported during that timeframe. - 16. *May 13, Food Poisoning Bulletin* (National) **Golden Smell Hotpot Meat Ball Medley recalled for undeclared egg.** Strong America Limited of New York, issued a recall for 1-pound packages of its Golden Smell Hotpot Meat Ball Medley due to undeclared egg. The product was distributed to retailers nationwide and sold through mail order.

17. May 12, U.S. Food and Drug Administration – (National) Stonyfield extends voluntary recall of YoBaby Peach/Pear yogurt cup 6-packs to 271 additional stores in 6 western states. The U.S. Food and Drug Administration announced May 12 that Stonyfield extended its April 25 voluntary recall of YoBaby Peach/Pear yogurt cup 6-packs to include an additional 1,344 packages due to possible coliform Klebsiella pneumoniae contamination.

18. *May 12, WLEX 18 Lexington* – (Kentucky) **Silo fire reported in Lincoln County.** Authorities believe a farm silo in Lincoln County caught fire May 12 after the corn silage contained inside dried out and overheated, causing an estimated \$75,000 in damage.

19. *May 12*, *WBBM 2 Chicago* – (Illinois) **Heavy rain leads to storm tunnel explosion in Calumet City.** Heavy rains May 11 overwhelmed the Deep Tunnel stormwater system in Calumet City, building up pressure in a sewer tunnel causing an underground hydraulic explosion that created a sink hole. The storms also caused streets to flood, knocked out power to nearly 9,000 ComEd customers, and prompted airlines at O'Hare International Airport to cancel more than 130 flights.

San Antonio Water System crews were working to repair the break, and stated that restoring full water pressure to downtown hospitals was a priority.
