#### **Top Stories**

- Sallie Mae reached two settlements with the U.S. Department of Justice May 13, agreeing to pay \$60 million to resolve excessive interest rates charged to military members and \$30 million to settle allegations that it maximized consumer late fee charges. *Associated Press* (See item 4)
- Authorities are investigating a fire that started May 12 that caused about \$1.4 million in damage at Robert Mann Packaging in Watsonville, California destroying thousands of cardboard boxes and containers. *Santa Cruz Sentinel* (See item 8)
- Two healthcare workers in Orlando fell ill and 20 others are being monitored after exposure to a Middle Eastern Respiratory Syndrome (MERS) patient, the second case in the U.S. *Reuters* (See item <u>13</u>)
- Officials lifted an evacuation for more than 20,000 residents in and around San Diego, and 1,200 homes and businesses in Santa Barbara County due to two wildfires that broke out in the Rancho Bernardo area of San Diego May 13. Associated Press (See item 21)

1. *May 14, KGTV 10 San Diego* – (California) **Winds knock out power to thousands in San Diego.** Strong winds in San Diego County caused around 12,946 customers to be without power May 13 due to downed power lines. Downed lines also caused three spot fires that also resulted in power outages.

2. *May 13, WRCB 3 Chattanooga* – (Tennessee) **EPB power outage from Hixson north into Graysville.** Around 32,000 EPB customers in Hamilton County, Tennessee, lost power after a TVA circuit that supplies EPB lost power and caused two outages. Power was restored later that day.

3. *May 13, Reuters* – (New Mexico) **Kitty litter eyed as possible culprit in New Mexico radiation leak.** A New Mexico environmental official stated that a February 14 radiation release at the Waste Isolation Pilot Plant may have been caused when kitty litter used as an absorbent may have caused a chemical reaction that melted seals on waste containers. Federal and State officials are continuing to investigate. Student loan lender Sallie Mae reached two settlements with the U.S. Department of Justice May 13, agreeing to pay \$60 million to resolve charges that it charged military members excessive interest rates and agreeing to pay \$30 million to settle allegations that it maximized consumer late fee charges. Sallie Mae also agreed to pay \$6.6 million in civil penalties as part of the settlement.

- 5. *May 14, Milwaukee Journal Sentinel* (Wisconsin) **Truck crash spills animal parts on highway, forcing closure.** Highway 26 in Fond du Lac County was closed for several hours May 14 after a truck carrying cattle parts lost control going around a curve and tipped over, spilling the waste onto the roadway. The driver was transported to a local hospital with minor injuries.

7. *May 14, WSTM 3 Syracuse; WTVH 5 Syracuse* – (New York) **Chemical spill in Cortlandville sends six to the hospital.** HAZMAT crews decontaminated six workers at the Buck Environmental Labs facility in Cortlandville after they were exposed to an unknown chemical spill inside the building May 13. Crews cleaned the spill and cleared the scene several hours later.

8. *May 13*, *Santa Cruz Sentinel* – (California) **Watsonville fire destroys home, more than \$1 million in packing material.** Authorities are investigating a fire that broke out May 12 at Robert Mann Packaging in Watsonville, destroying thousands of cardboard boxes and plastic clam shell produce containers and causing about \$1.4 million in damage.

9. *May 13, U.S. Food and Drug Administration* – (International) **US Trading Company voluntary recall of crushed chili powder because of possible health risk.** The U.S. Food and Drug Administration (FDA) announced May 13 that US Trading Company of Hayward, California, issued a nationwide recall for 6.3 ounce plastic tubs of its Dragonfly Brand Crushed Chili Powder, a product of Thailand, due to possible Salmonella contamination. The recall was initiated as a result of routine sampling by the FDA.

10. May 13, U.S. Department of Labor – (New Jersey) Star Snacks Co. LLC fined \$180,000 by US Department of Labor's OSHA for willfully exposing employees to carbon monoxide and dangerous noise levels. The Occupational Safety and Health Administration cited Star Snacks Co. LLC for two willful and six serious safety violations, including willfully exposing workers to high levels of carbon monoxide and dangerous noise levels at the company's Bayonne facility. Proposed penalties total \$180,000.

- 11. *May 14, Ann Arbor News* (Michigan) **29,000 gallons of partially treated sewage enters Saline River during overflow.** A contractor error while making improvements at the City of Saline Wastewater Treatment Plant (WWTP) caused a total of 146,000 gallons of partially treated wastewater to be released from WWTP, of which 29,000 gallons emptied into the Saline River via a storm water collection system. Cleanup was expected to be completed May 13.

The phishing campaign attempts to use the way Chrome displays data Uniform Resource Identifiers (URIs) to trick users in to logging into a fake Google login page.

At least 2 high schools and three elementary schools were evacuated May 12 as a result of the fires.

Columbia Gas crews capped the leak over 2 hours later and deemed the evacuated buildings were safe for occupation.
