- A bus overturned on Interstate 10 in Blythe, California May 21, killing 4 people, injuring at least 7 others, and causing the highway to be closed in both directions for several hours. *Associated Press* (See item 7)
- Thirty-seven people from 18 States were infected between January and May with a strain of Salmonella Typhimurium after coming in contact with contaminated frozen feeder mice packaged by Reptile Industries Inc. *Food Safety News* (See item <u>13</u>)
- Crews worked May 21 to contain a wildfire that began May 20 in Coconino National
 Forest near Sedona, Arizona and burned at least 1,000 acres, triggering the evacuation of
 Coconino County residents and prompting part of State Route 89A to close indefinitely. –

- eBay advised all users to change their passwords after it detected an intrusion that compromised a database containing encrypted passwords and other non-financial data. – *Softpedia* (See item <u>27</u>)

Nuclear Reactors, Materials, and Waste Sector

1. *May 20, Pittsburgh Tribune-Review* – (Pennsylvania) **Vibrating pump prompts shutdown of Beaver Valley nuclear reactor.** Operators at the Beaver Valley Power Station in Shippingport shut down the plant's Unit 2 reactor May 20 as it was returning from a refueling outage due to a pump that was vibrating. Workers found no problems and then began the restart process.

2. May 20, Associated Press – (New Mexico) New Mexico says 57 nuke containers could be threat. The Secretary of the New Mexico Environment Department stated that 57 barrels of radioactive waste originating from the Los Alamos National Laboratory (LANL) and deposited at the Waste Isolation Pilot Plant (WIPP) near Carlsbad potentially pose a substantial threat to public health, and the Secretary issued an order requiring the LANL to submit a plan for securing the containers within 2 days. May 20, Los Angeles Times (National) **GM issues more recalls, this time for 2.42 million vehicles.** General Motors issued recalls May 20 for a total of 2.42 million vehicles of several models from the 2000-2015 model years for four separate issues. - 4. May 20, U.S. Department of Labor (Massachusetts) After explosion, US Department of Labor's OSHA cites 3-D printing firm for exposing workers to combustible metal powder, electrical hazards. The Occupational Safety and Health Administration cited Powderpart Inc., for one willful and nine serious violations at its Andover facility following an inspection prompted by a November 5, 2013 explosion and fire. Proposed fines totaled \$64,400.

5. May 20, U.S. Department of Labor – (Wisconsin) US Department of Labor's OSHA proposes \$51,800 in fines for Power Coatings for failing to protect workers from toxic chemical hazards. The Occupational Safety and Health Safety Administration cited Power Coatings LLC for 14 serious safety violations at its Janesville facility. Proposed penalties totaled \$51,800.

7. *May 21, Associated Press* – (California) **Spilled cargo causes bus crash that kills 4.** An El Paso-Los Angeles Limousine Express Inc. bus overturned, sliding across the shoulder and down an embankment on Interstate 10 in Blythe, killing 4 people and seriously injuring at least 7 others after the bus either swerved or struck a load of steel pipes left on the highway from a previous semi-truck that had jackknifed. All interstate lanes were closed for several hours after two other vehicles in the eastbound lanes also crashed.

8. *May 21, WBBM 2 Chicago* – (Illinois) **Severe storms bring flooding, damage from hail and lightning.** Powerful storms in the Chicago area May 20 caused flooding along roadways, forced the cancellation of more than 115 flights at O'Hare International

Airport, and closed all but one outbound lane on Interstate 55 near County Line Road due to standing water.

9. *May 21, KXII 12 Sherman* – (Texas) **Train derails in Gainesville.** Authorities are investigating a Burlington Northern Santa Fe Corp. train derailment in Gainesville, Texas, that caused between 20 to 100 cars to go off the track May 20. The derailment knocked out power to nearby homes and police advised residents to avoid the area during cleanup efforts.

- 10. *May 20, KMTV 3 Omaha* (Iowa) **Hydrogen peroxide leaks onto I-29 and shuts it down for hours.** All lanes of Interstate 29 in Council Bluffs were closed for several hours May 20 after hydrogen peroxide spilled from a semi-truck onto the interstate. 13. May 20, Food Safety News – (National) 37 Salmonella cases in 18 States linked to frozen feeder rodents. The U.S. Centers for Disease Control and Prevention announced May 20 that 37 people from 18 States were infected between January 11 and May 13 with an outbreak strain of Salmonella Typhimurium after coming in contact with frozen feeder rodents packaged by Reptile Industries Inc., that were distributed to PetSmart stores nationwide. The U.S. Food and Drug Administration issued a warning May 20 advising against the use of frozen mice packaged by the

company since January 11 due to possible Salmonella contamination.

14. *May 20, WSAZ 3 Huntington* – (Ohio) **Meigs County residents indicted for crop insurance fraud.** Five Meigs County, Ohio residents were indicted by a federal grand jury for an allegedly applying for \$1,563,337 in fraudulent payments from the federal Non-Insured Crop Assistance Program after an investigation launched by federal officials August 2012 revealed the alleged scheme.

15. May 20, U.S. Department of Labor – (Arkansas) US Department of Labor's OSHA cites Tortillas Ricas LP for serious health and safety violations with \$48,300 in fines. The Occupational Safety and Health Administration (OSHA) cited Tortillas Ricas LP, doing business as Casa Rica Tortillas, for 13 serious safety and health violations at the company's Plainview facility following a February 2013 inspection under OSHA's National Emphasis Program on combustible dust. Proposed penalties totaled \$48,300.

Middle East Bakery, Inc. issues allergy alert on undeclared milk in Market Basket
Dairy-free, Gluten-free Pancakes. The U.S. Food and Drug Administration
announced May 19 that Middle East Bakery of Lawrence, Massachusetts, issued a
recall for all lots of its Market Basket Dairy-Free, Gluten-Free Pancakes due to
undeclared milk. The products were sold in 14.4-ounce packages at Market Basket
Supermarket Stores in Massachusetts and New Hampshire.

17. *May 21, Roanoke Times* – (Virginia) **Major leak to be fixed at Roanoke's Crystal Spring Reservoir.** A utilities director for the Western Virginia Water Authority stated that Roanoke's Crystal Spring Reservoir is leaking an estimated 500 gallons of drinking water a minute due to cracks in the reservoir's concrete lining, costing the authority around \$250,000 annually. Water authority officials are planning a \$1.5 million project to reduce leakage.

were advised May 20 to boil their water as a precaution after water supplies ran low due to water filtration issues at a treatment plant in Norristown.  C after learning that a former hospital employee may have exposed them to the disease
 by taking hospital drugs for personal use. The patients received care from the former
 worker and were administered drugs during their time at the hospital.

- 21. *May 21, KTAR 92.3 FM Glendale; Associated Press* (Arizona) **Wildfire roaring in canyon near Sedona.** Crews worked May 21 to contain a wildfire that began May 20 in Coconino National Forest near Sedona and burned at least 1,000 acres, prompting the evacuation of Coconino County residents as officials reported that over 100 businesses and homes were threatened by the blaze. State Route 89A was closed indefinitely between Fort Tuthill in Flagstaff and Sedona.
