- 1. June 11, WOWK 13 Charleston (Kentucky) Power outage causes air release at Marathon Oil refinery in Catlettsburg, KY. Authorities are investigating and are taking air quality samples in order to resolve start-up problems after a Marathon Oil Corporation plant in Catlettsburg lost power causing an air release June 10. ## **Chemical Industry Sector**

3. June 11, Burlington County Times – (Pennsylvania; New Jersey) Chemical spill spreads fumes across the Delaware. Approximately 300 gallons of ethyl acrylate spilled at Arkema Chemical's Altuglas facility in Bristol Township, Pennsylvania, June 10 when a container fell off a forklift and led to strong fumes, which prompted a shelter-in-place order for students at a nearby elementary school. Plant employees contained the spill and are working to remove the asphalt onto which the chemical spilled.

# Nuclear Reactors, Materials, and Waste Sector

4. June 11, Associated Press – (New Mexico; Texas) Officials say 6 barrels of waste in Texas tied to nuke dump leak. The New Mexico Environment Secretary reported that investigators identified five barrels of highly acidic radioactive waste that are from the same waste stream as a barrel that was involved in a chemical reaction that leaked radiation at the Waste Isolation Pilot Project in New Mexico. The five barrels are currently stored at Los Alamos National Laboratory in New Mexico and at Waste Control Specialists in Andrews, Texas.

5. June 9, News 12 Westchester – (New York) Radioactive groundwater spikes under Indian Point in Buchanan. The U.S. Nuclear Regulatory Commission (NRC) reported that a spike in tritium levels was found in groundwater monitoring wells beneath the Indian Point Power Plant in Buchanan in April, and that inspectors are working to find the cause of the tritium leak. Tritium levels fell sharply after the spike was detected, and the NRC suspects the tritium may have leaked from a canal that is flooded and used to move fuel to a cooling pool.

6. June 11, Autoblog – (International) Toyota expands airbag recall to 2.27M vehicles worldwide. Toyota announced the expansion of a recall for faulty airbag inflators manufactured by Takata, recalling 766,300 model year 2003-2004 Corolla, Matrix, and Tundra vehicles and model year 2002-2004 Sequoia and Lexus SC430 vehicles in the U.S. The recall covers previously recalled vehicles in order to recheck the vehicles as well as vehicles identified from an improved list of part serial numbers supplied by Takata.

A former Rabobank Group trader pleaded guilty in U.S. court June 10 to charges of wire fraud and bank fraud for conspiring to manipulate the London interbank offered rate (LIBOR) used to determine benchmark interest rates. Rabobank previously agreed to a \$325 million settlement with the U.S. to resolve charges that the bank was involved in LIBOR manipulation. Police stated that they believe the two women were acting as part of a larger payment card fraud ring.
