- The U.S. Centers for Disease Control and Prevention reported June 19 that as many as 75 scientists working in federal government laboratories in Atlanta may have been exposed to live anthrax bacteria after failing to follow proper procedures. *Reuters* (See item 22)
- A King County, Washington sheriff's deputy was arrested June 19 and charged for
  prostituting his wife, drug dealing, and stealing from the department after officials found
  that he along with two other deputies were involved in alleged corruption and other

1. June 20, Associated Press – (Pennsylvania) Lightning damages properties; storm kills power to thousands. Utility crews worked to restore power to about 30,000 customers in Bucks County, Pennsylvania, June 19 after wind and rain knocked out service.

2. June 19, New Orleans Times-Picayune – (Louisiana) Foul odor in St. Rose caused by refining crude oil that produced sulfur compounds, DEQ says. The Louisiana Department of Environmental Quality announced June 19 that the cause of a rancid odor that lingered for several days beginning June 7 in St. Rose was linked to the refining of crude oil that contained high levels of sulfur compounds at an asphalt production plant in St. Charles Parish. Both International-Matex Tank Terminals and Shell Chemical are removing the asphalt product made from the crude oil at their plant and are upgrading their odor protection and reporting system.

- 3. *June 20, Associated Press* (Nebraska) **Nuclear plant north of Omaha prepares for flooding.** The operators of the Fort Calhoun nuclear power plant near Omaha stated that the plant would reduce power as it prepares to deal with rising waters on the Missouri River. Temporary sandbag berms were constructed at the plant and equipment including flood doors and mobile pumps were ready in case of flooding.

- 4. June 19, Lower Hudson Valley Journal News (New York) Feds: Indian Point may have ongoing tritium leak. U.S. Nuclear Regulatory Commission officials stated June 19 that samples collected from monitoring wells near the Indian Point nuclear power plant's Unit 2 reactor in New York showed tritium levels in groundwater increasing and then decreasing, pointing to a possible ongoing leak of the radioactive substance. The amount of tritium found does not pose a threat to plant workers or the public. Two airports were compromised before authorities discovered the operation.

12. June 20, WNBC 4 New York City – (New York) 6 hurt when garbage truck slams into Brooklyn deli: NYPD. At least 6 people were injured June 20 when a Metropolitan Recycling garbage truck crashed into a deli in the Brooklyn area of New York City after the driver swerved to avoid colliding with a vehicle that failed to stop at a red light. The structure suffered heavy damage, prompting an evacuation of residents from apartments inside the building and an adjacent structure while crews cleared the scene

13. *June 19*, *Associated Press* – (California) **California expands Asian citrus psyllid quarantine.** The California Department of Food and Agriculture announced June 19 that it expanded an Asian citrus psyllid quarantine in Tulare County to include an

additional 14 square miles. Other California counties are also under quarantine in the State's effort to prohibit the movement of nursery stock of the insect that can carry a bacteria that is deadly to citrus trees.

14. June 19, Associated Press – (National) Kraft Foods recalls Velveeta due to spoilage, illness concerns. Kraft Foods Group Inc., issued a recall June 19 for 260 cases of Velveeta original pasteurized recipe cheese sold at Walmart stores in as many as 12 States due to insufficient levels of sorbic acid, a preservative, that could result in premature spoilage or cause food-borne illnesses.

15. June 19, Lancaster Intelligencer Journal/Lancaster New Era – (Pennsylvania) Cattle rescued from burning barn in Rapho Township. Firefighters responded to a fire June 19 at a farm in Rapho Township that started at a silo unloader and conveyor belts, causing damage to an attached barn. The fire was contained before it spread into the silo and farmers rescued 50 to 75 cattle.

The Food Safety and Inspection Service announced June 19 that Michigan-based Dearborn Sausage Co., issued a recall for about 3,660 pounds of Randy's Slab Bacon due to undeclared hydrolyzed soy protein caused by mislabeling. The issue was discovered during a routine FSIS safety assessment.

- 17. June 19, U.S. Department of Agriculture (National) Ohio firm recalls Chicken Pad Thai product due to misbranding and undeclared allergen. The Food Safety and Inspection Service announced June 19 that Bellisio Foods, Inc., recalled approximately 12,180 pounds of a Thai Kitchen Chicken Pad Thai frozen entree product due to misbranding and undeclared soy protein isolate. The product was sold in 8-pack cases of 10-ounce packages and distributed to retailers nationwide.

California Cereal Products Inc., was cited by the Occupational Safety and Health Administration June 19 for 9 serious workplace safety and health violations following a December 2013 inspection of the company's production facility in Macon. Proposed penalties totaled \$40,600.

The Occupational Safety and Health Administration cited Maplewood Beverage Packers LLC June 18 for 21 workplace health and safety violations at the company's Maplewood bottling facility following a December 2013 investigation initiated after a temporary worker fell from a ladder and was injured. Temporary employment agency Corporate Resource Services Corp., was also cited and proposed penalties totaled \$182,270.

The U.S. Department of the Treasury's Office of Inspector General released an audit claiming Indiana intentionally misused federal funds when its contractor, Elevate Ventures, funneled \$499,986 in federal cash to a start-up business called Smarter Remarketer managed by the firm's chairman. Indiana officials claim the investment was fully recovered and both entities will follow new policies and practices to ensure funds are appropriately used in the future.

The employees are being tested and an internal investigation is underway.

The deputy also allegedly convinced his estranged wife to work as a prostitute, taking 80 percent of her earnings.

26. *June 20, Softpedia* – (International) **OpenSSL vulnerability addressed in Android 4.4.4 updates.** Google released an update for Android KitKat, version 4.4.4, which closes a significant OpenSSL injection vulnerability in the crypto library. The update will be deployed to Nexus devices automatically, though factory images were also made available for manual updating.

27. June 20, Help Net Security – (International) Critical flaw exposes admin passwords of nearly 32,000 servers. A researcher with CARI.net's Security Incident Response Team discovered that 31,964 servers with Supermicro baseboard management controllers (BMCs) will disclose their password files in plain text to anyone who connects to port 49152. The issue was fixed in a patch, but the patch requires administrators to reflash their systems with a new IPMI BIOS, which is not always possible.
