- Arkansas State Troopers arrested a suspect known as the "Loan Ranger Bandit" July 1 and charged him with 11 counts of robbery in connection with the robbery of banks in Texas, Arkansas, and Mississippi. *KETK 56 Jacksonville* (See item 8)

- Residents in low-lying areas along the Iowa River in Johnson County, Iowa, received
  mandatory evacuation notices July 2 due to rising water from the Coralville Lake Reservoir

1. July 2, Salt Lake City Deseret News – (Utah) Green River oil spill visually clean, but monitoring continues. The U.S. Bureau of Land Management reported July 2 that it could take up to 2 years before they issue a complete all-clear to the site of a May 21 oil well leak that reached the Green River in Salt Lake City after officials issued a preliminary all-clear in June. The bureau reported that it will continue monitoring the site and is awaiting a response from the well's operator, SW Energy, after issuing a violation notice.

Corrosive materials, including potassium chloride, leaked from the trailer of a semi-truck parked at the West Virginia Welcome Center on 1-79 in Monongalia County for about 12 hours July 2. The welcome center was closed for several hours while crews contained the spill and cleaned the scene. No injuries were reported and air monitoring did not reveal any off-site impacts.

Traffic was diverted for over 1 hour while crews cleared the scene.

5. July 3, Chicago Tribune – (National) Subaru recalling 660,238 vehicles in U.S. due to brake line rust. Subaru announced July 3 that it is recalling 660,238 model year 2005-2014 Forester, Impreza, Legacy, and Outback vehicles registered in cold-weather U.S. States due to the potential for brake lines to corrode and leak brake fluid, reducing the effectiveness of the vehicles' brakes.

- 10. *July* 2, *Associated Press* (New York; California) **Ex-NY policeman pleads guilty to company theft.** A former New York police officer who was also the former vice president of Fidelity National Title Group pleaded guilty July 2 to stealing roughly \$469,000 from the company and spending it on gambling. In 2009 the suspect arranged for a vendor to send the money to a bank account he controlled and used the funds for personal use.

- 11. July 2, Securityweek (International) New Android malware targets banking apps, phone information: FireEye. FireEye researchers identified a piece of Android malware known as HijackRAT that disguises itself as a 'Google Service Framework' and is capable of disabling antivirus applications, stealing banking credentials and personal information, and remotely accessing infected devices. The malware is currently targeting banks in Korea but can be easily modified to target others. - 12. July 2, U.S. Securities and Exchange Commission (Minnesota) Court imposes officer and director bar, injunction and monetary sanctions against Minneapolis attorney based on fraud verdict. The U.S. Securities and Exchange Commission announced July 2 that a judge imposed sanctions against a Minneapolis attorney, Capital Solutions Monthly Income Fund, and Transactional Finance Fund Management (TFFM) for allegedly engaging in securities fraud by issuing false and misleading statements to investors and fraudulently issuing a series of unregistered offerings of interest. The attorney was barred from serving as an officer or director of a publicly traded company for 10 years, and sanctions totaling \$19.7 million were levied against the attorney, the fund, and TFFM.

A San Diego certified public accountant was convicted June 30 for running an identity theft and tax evasion scheme where he used the identities of deceased individuals to open bank accounts and then transferred funds to those accounts in order to hide his income from the Internal Revenue Service. The man failed to report \$5 million in income and owed the IRS \$1.6 million. The U.S. Army entered into a settlement with the U.S. Environmental Protection Agency July 2 after inspections at Fort Wainwright Garrison in Alaska found that from at least 2012 to 2013 Fort Wainwright failed to perform leak detection tests, monitor underground storage tanks regularly, and investigate releases as required by law. The U.S. Army agreed to improve management of its fuel storage tanks and comply with federal law designed to protect groundwater and pay a penalty of \$158,700. Source:

Cisco warned users of its Unified Communications installations that a vulnerability exists in its Unified Communications Domain Manager (Unified CDM) software that can allow an unauthenticated attacker to gain root access by exploiting a default SSH key designed for use by Cisco support representatives. The vulnerability is present in all versions of Cisco Unified CDM prior to version 4.4.2 and users were advised to update the software, or to filter SSH access as a stopgap measure.
