1. July 13, Forum of Fargo-Moorhead – (North Dakota) 760 barrels of oil reported stolen in North Dakota oil patch. Authorities are investigating after about 760 barrels of crude oil worth an estimated \$80,000 were stolen from tanks at two Cornerstone Natural Resources-owned well sites near Dunn County. K&R Roustabout reported the theft after a worker maintaining the tanks reported that the amount of oil calculated came up short.

2. July 12, Associated Press – (New Mexico) Air pollution allegations lead to settlement in NM. Regency Field Services LLC reached a settlement with the New Mexico Environment Department July 11 and agreed to pay nearly \$70,000 to settle violations at its natural gas plant in Santa Fe which included failure to demonstrate compliance with certain emissions limits and failure to maintain certain records. The plant was also accused of failing to conduct certain tests and not checking if monitoring equipment was working properly.

## **Chemical Industry Sector**

3. July 14, WGOW 1150 AM Chattanooga – (Tennessee) Workers evacuate after chemical company Haz-Mat fire. Between 2,000 and 3,000 gallons a caustic soda spilled and started a fire at the JIT Chemicals facility in Chattanooga while workers were transferring a sodium hydroxide solution from a barge into a storage tank July 11. One worker was contaminated and transported to an area hospital, and crews extinguished the blaze and cleaned the spill.

- 4. July 13, WGRZ 2 Buffalo (New York) Tonawanda fire crews douse chemical fire. Employees at a PeroxyChem facility in Tonawanda were evacuated and the sprinkler system inside the warehouse was triggered July 12 when a chemical substance caught fire in oxidizer equipment and started smoking. Firefighters responded and investigators are searching for the cause of the fire.

- 5. July 11, KPRC 2 Houston (Texas) Highway 59 reopens after truck carrying explosive chemicals closes freeway. The refrigeration system on a FedEx truck

carrying 200 gallons of liquefied peroxide, a chemical that explodes when it is rises above 50 degrees, malfunctioned along Highway 59 in Liberty County July 11, prompting the closure of the freeway and evacuation of a business. The driver pulled the vehicle off the road and HAZMAT crews took protective actions to avoid an explosion and clear the scene, allowing the freeway to reopen.

6. July 11, Lacey Patch – (New Jersey) Oyster Creek shut down again for second time this week. The operators of the Oyster Creek Generating Station in New Jersey took the plant's reactor off line July 11 after detecting a reduction in steam condenser vacuum. The shutdown was the second in the past week following a July 7 shutdown due to degradation in five electromatic relief valves.

8. July 14, The Register – (International) FBI: We found US MILITARY AIRCRAFT INTEL during raid on alleged Chinese hacker. A Chinese man was arrested by Canadian authorities at the request of the FBI for working with two other uncharged suspects and allegedly hacking into several defense contractors' networks in the U.S. and Europe in order to steal information on 32 U.S. projects, including the U.S. Lockheed F-22 and F-35 aircraft and Boeing's C-17 cargo plane. Authorities alleged the suspects were able to extract several thousand digital files and attempted to sell the information off to State-owned companies in China.

9. July 13, Reuters – (International) 'Excessive' rubbing of engine blades caused F-35 failure: Pentagon. U.S. Department of Defense officials announced July 13 that excessive rubbing of fan blades likely caused a June 23 engine fire on a U.S. Air Force F-35 that resulted in a grounding of the entire fleet. Authorities stated that investigations did not reveal signs of similar wear on any of the remaining 97 aircraft in the fleet and the issue does not appear to be a design flaw.

The malware contains HTML injection and form-grabbing capabilities, allegedly works with modern and older Web browsers, and is compatible with the Zeus trojan.

12. *July 13*, *Baton Rouge Advocate* – (National) **Hedge fund owner pleads guilty to mail fraud.** A Zachary, Louisiana hedge fund manager who operated Greenwing Capital Management LLC pleaded guilty July 11 to defrauding investors in Louisiana, Florida, Mississippi, and Texas of around \$13 million by delivering false statements to investors showing profits when most investments failed or were used by the hedge fund owner for personal use.

Service resumed July 14 and the incident is under investigation.

Officials arrested a suspect July 12 accused of causing a fire after the exhaust from his truck ignited the 3,700-acre Bully Fire in Redding as he was delivering material to a marijuana cultivation site in Shasta County. Crews reached 10 percent containment July 13 of the wildfire while 15 homes and about 50 other structures remained under threat.

The investment placement agent was also charged for his role in the scheme which included falsifying facts about investor disclosure letters and conspiring to commit fraud.

LastPass, My1Login, RoboForm, and PasswordBox reported that they closed the vulnerabilities after they were reported, while the researchers did not receive word on the issues from NeedMyPassword. U.S. officials issued an advisory to hospitality industry companies encouraging them to secure their public computers and limit guest accounts to non-administrator accounts following the arrest of a group of individuals that are suspected of compromising computers in Texas hotel business centers. The suspects allegedly used stolen credit cards to register as hotel guests and used the hotel's business center to download and execute key logging software, which was used to capture the information of other guests.
