1. *July 22, Associated Press* – (North Dakota) **Fire burns in industrial part of North Dakota town.** A July 22 fire at the Red River Supply in the town of Williston prompted authorities to set up an evacuation zone with a half-mile radius and caused a stretch of State Highway 1804 to close while emergency personnel assessed the damage.

2. *July 22, Securityweek* – (International) **Attackers bypass 2FA systems used by banks in ‘Operation Emmmental’.** Researchers with Trend Micro released a report July 22 detailing a cybercrime campaign targeting banks in Europe and Japan dubbed “Operation Emmmental” that uses computer and Android mobile device malware to steal users’ banking credentials and two-factor authentication (2FA) tokens. The malware used in the campaign can install fake Secure Sockets Layer (SSL) certificates, delete itself after use, and perform other actions to trick users.

3. *July 21, Krebs on Security* – (National) **Banks: Card breach at Goodwill Industries.** Goodwill Industries stated that it is working with the U.S. Secret Service to investigate a possible breach of payment card data from some of its U.S. stores. The company stated that it became aware of a possible breach July 18 after they were contacted by a payment card industry fraud investigation unit and federal authorities.

4. *July 21, KVTX 3 Phoenix* – (California) **147 fraudulent debit, credit cards seized; 2 people arrested.** Two people were arrested July 21 in Blythe, California, by Yuma Sector Border Patrol agents after 147 fraudulent debit and pre-paid cards were found during a vehicle stop.

5. *July 21, NextGov* – (National) **Significant deficiencies found in Treasury's computer security.** Two reports by the Government Accountability Office released the week of July 14 found new computer security vulnerabilities at the U.S. Department of the Treasury's Bureau of Fiscal Service and existing security issues at the Federal Deposit Insurance Corporation that remain unaddressed from 2012 which could compromise reporting efficiency or the security of data.

6. *July 22, Associated Press* – (International) **US Airlines scrap Israel flights over missile fear.** Delta Air Lines and United Airlines cancelled all flights to Israel until further notice July 22 due to safety and security concerns after reports that a rocket landed near Tel Aviv Ben Gurion Airport. US Airways also cancelled a flight from Philadelphia headed to Tel Aviv as a precaution.

7. *July 22, New 12 Westchester* – (New York) **2,000 gallons of oil spills in Woodbury crash.** Route 6 and Route 293 in Woodbury, New York, were closed for several hours July 21 after a semi-truck collided with another vehicle and flipped over westbound Route 6 spilling about 2,000 gallons of oil.

8. *July 21, WVEC 13 Hampton* – (Virginia) **Tanker truck misses turn; ends up in ditch, causing major traffic woes.** Eastbound lanes of U.S. Route 58 near Chesapeake,

Virginia, were closed for 7 hours July 21 when a semi-truck carrying 5,500 gallons of gasoline and 2,000 gallons of diesel crashed into a ditch. There was no spillage and officials spent several hours pulling the semi-truck out of the ditch and transferring the gasoline and diesel to another semi-truck.

9. *July 19, WBZ 4 Boston* – (Massachusetts) **Hot air balloon crashes into power lines in Clinton; several injured.** A Colt Balloon-owned hot air balloon crashed into a power line in Clinton, Massachusetts, July 19 while attempting to land, injuring five people. The accident also caused approximately 600 National Grid customers to lose power for several hours.

10. *July 21, U.S. Food and Drug Administration* – (National) **FDA consumer advice on powdered pure caffeine.** The U.S. Food and Drug Administration issued a warning July 21 advising against the consumption of powdered pure caffeine sold in bulk bags over the Internet due to the high potency of the product that can result in accidental overdose. At least one death has been linked to the product.

11. *July 20, Food Poisoning Bulletin* – (California) **Sysco pays \$19.4 million for dangerous food storage practices.** Sysco Corporation entered into an agreement with the State of California and will pay \$19.4 million in restitution settle reports that the company stored over 400,000 meat, produce, and dairy products in unsafe conditions, including unrefrigerated and dirty storage units, between July 2009 and August 2013. An investigation by health officials also revealed that the products were delivered to restaurants, hospitals, and schools in unrefrigerated cars, and there were 25 unregistered and unrefrigerated drop sites from Sacramento to San Diego.

12. *July 18, Food Poisoning Bulletin* – (National) **Salmonella outbreak linked to chia powder grows to 25.** The U.S. Centers for Disease Control and Prevention reported that as of July 14 a total of 25 individuals in 15 States have been sickened by a Salmonella outbreak linked to organic sprouted chia powder. Officials stated that the individuals were infected with three strains of the bacteria, including Salmonella Newport, Salmonella Hartford, and Salmonella Oranienburg.

13. *July 18, Associated Press* – (Wisconsin) **Seven more counties added to emerald ash borer quarantine.** The Wisconsin Department of Agriculture expanded the State's emerald ash borer quarantine July 18 to include 7 additional counties, bringing the total number of counties under quarantine to 29. Officials discovered the insect in 3 of the counties that were added to the quarantine, which limits the transport of firewood and requires wood handling businesses to consult State officials for an inspection of products prior to shipment.

14. *July 22, Fayetteville Observer* – (North Carolina) **3,500 gallons of wastewater spill into Thornton Creek Monday.** A power outage July 21 prompted 3,500 gallons of wastewater to spill into Thornton Creek in Lillington due to an overflow of diluted wastewater at a sewer lift station. Authorities started pump and haul procedures and applied lime.

The computers held spreadsheets containing patients' personal information.

16. *July 21, KGW 8 Portland; Associated Press* – (Oregon) **Oregon's largest fire complex 396,000 acres.** Crews reached 75 percent containment July 21 of the Buzzard Complex after burning 396,000 acres in Oregon. Fire departments worked to contain several other complex fires in the State that combined burned more than 200,000 acres by July

20.

17. *July 21, Associated Press* – (Washington) **Better weather aiding Washington wildfire fight.** Fire crews reached 2 percent containment July 21 of the Carlton Complex of fires which burned 243,000 acres in north-central Washington. About 150 homes were destroyed and one person died of an apparent heart attack while fighting the fire near his home.

Officials cleared the scene after searching the building and continue to investigate the incident.

20. *July 22, Securityweek* – (International) **iOS backdoors expose personal data: Researcher.** A security researcher presenting at a security conference reported that Apple's iOS mobile operating system contains several undocumented services which could be used in some circumstances to access email, location data, media, and other personal data. Apple stated that the services are used for diagnostic purposes and can only be used to access data with user approval.

21. *July 21, V3.co.uk* – (International) **Fresh threat to critical infrastructure found in Havex malware.** Researchers at FireEye analyzed a variant of the Havex malware (also known as Fertger or Peacepipe) and found that it contained an open-platform communication (OPC) scanner that could be used to target supervisory control and data acquisition (SCADA) systems used by several industries, including power plants and water utilities.

22. *July 22, WCAU 10 Philadelphia* – (New Jersey) **Masked robbers steal over \$180K from Caesars casino.** Police are searching for two masked robbers that stole over \$180,000 from the Caesars Atlantic City casino in New Jersey July 21 when at least one suspect brandished a gun and both individuals stole two plastic cash boxes holding the money.

No injuries were reported and up to 135 residents were displaced by the blaze.

25. *July 21, Associated Press* – (Florida) **Second finger injury reported on Disney World ride.** A report made public by the Florida Department of Agriculture and Consumer Services July 21 stated that a child suffered lacerations to four fingers while on Walt Disney World's Pirates of the Caribbean ride in Lake Buena Vista during April. Disney officials are no longer loading guests into the back row of the ride due to a similar incident in July that resulted in a guest losing two fingertips.

26. *July 21, U.S. Department of Labor* – (Ohio) **US Labor Department's OSHA cites Ohio Lowe's for repeat electrical hazards.** Lowe's Cos. Inc., was cited by the Occupational Safety and Health Administration for five repeat and one serious workplace safety violations after a March 2014 inspection of the company's Zanesville store revealed that workers were exposed to electrical hazards and were not provided information on respiratory protection. Proposed penalties total \$53,240.
