1. *August 12, KSNF 16 Joplin; KODE 12 Joplin* – (Kansas) **Two people injured after explosion at Jake's Fireworks in Pittsburg.** Two individuals were injured by an explosion while moving fireworks into a storage unit at the Jake's Fireworks store in Pittsburg, Kansas, August 12. The cause of the explosion is under investigation.

2. *August 12, U.S. Department of Labor* – (Illinois) **OSHA inspection finds workers exposed to multiple safety and health hazards at Joliet, Illinois, chemical distribution company.** The Occupational Safety and Health Administration cited Seeler Industries, Inc., for 19 safety and health violations at the company's 3 Rivers Terminal chemical facility in Joliet after a February inspection revealed that workers were exposed to hazardous chemicals and the company did not provide employees with appropriate training. Proposed penalties total \$134,400.

3. *August 13, U.S. Consumer Product Safety Commission* – (International) **ESL, Interlogix hard-wired smoke alarms recalled due to failure to alert consumers of a fire.** Edwards issued a recall for around 154,000 ESL and Interlogix 400 Series and 500 Series smoke detectors in the U.S. and Canada due to the potential for radio frequency interference to cause the detectors to fail to alert consumers of a fire.

Michigan caused by heavy rainfall closed the General Motors (GM) Warren Technical Center August 12 and impacted several other GM, Ford, and Chrysler manufacturing facilities in the metro Detroit region. Ford also reported that vehicle manufacturing facilities in Illinois and Kentucky experienced production interruptions due to the disruption in supplies coming from affected Michigan plants.

5. *August 12, Bergen County Record* – (New Jersey) **Bergen County father and son agree to pay \$5.5 million settlement in fraud case.** Two men from Bergen County agreed August 12 to pay \$5.5 million to settle New Jersey Bureau of Securities charges that they defrauded around 30 investors by using misleading or false statements to sell unregistered 5-year notes in Metropolitan Ambulatory Surgical Center, a holding company one of the men controlled. .

8. *August 13, KLTN 7 Tyler* – (Texas) **Evacuations lifted in fatal Rusk Co. pipeline**

explosion. Officials lifted evacuation orders for residents in Rusk County nearly 5 hours after an Enbridge-owned, 12-inch natural gas pipeline exploded on Farm to Market 1798 East near Henderson August 12. One person died at the scene after breaking the line while using a mowing tractor, causing an explosion and prompting the closure of the roadway.

About 50 people were evacuated from the warehouse while crews shut off the broken valve.

13. *August 12, Food Poisoning Bulletin* – (Montana) **Three food vendors closed at western Montana fair.** Health officials ordered three Northstar food vendors to close August 8 after inspectors found that hundreds of pounds of food were improperly refrigerated for several days, among other health violations while the vendors visited a

fair in Missoula County.

14. *August 12, Food Poisoning Bulletin* – (Minnesota) **Potato salad ingredient likely cause of Fond du Lac E.coli outbreak.** Minnesota Department of Health representatives reported that an E. coli outbreak that sickened 60 individuals who attended three different events on the Fond du Lac reservation between July 11 and July 16 is likely over and the last reported case was on July 20. Investigators believe an ingredient in a potato salad that a caterer served at two of the three events is likely the source of the outbreak.

15. *August 12, U.S. Department of Agriculture* – (National) **Georgia firm recalls chicken nugget product due to possible foreign matter contamination.** The Food Safety and Inspection Service announced August 12 that Perdue issued a recall for about 15,306 pounds of its frozen, fully cooked Applegate Naturals Chicken Nuggets due to possible contamination with foreign materials. The product was packaged in 8-ounce boxes that yield a sell by date of February 5, 2015 and were distributed to retailers nationwide.

16. *August 11, U.S. Food and Drug Administration* – (National) **Sunfood recalls Organic Carob Powder because of possible health risk.** The U.S. Food and Drug Administration announced August 11 that Sunfood of El Cajon, California, issued a recall for its Organic Carob Powder due to possible human health risks after a supplier for the product notified the company that an ingredient used during the manufacturing process may be contaminated with Salmonella. The product was distributed nationwide through retail stores and mail orders.

18. *August 12, Washington Post* – (Washington, D.C.; Virginia) **Dermatologist who worked in Virginia, the District indicted on fraud charges.** The owner of Skin & Laser Surgery Center in McLean, Virginia, was charged August 12 by federal authorities for intentionally misdiagnosing patients with skin cancer and performing unnecessary surgeries as part of a health-care fraud scheme across several Virginia and Washington, D.C. offices. Authorities alleged that the dermatologist would direct unlicensed and unqualified medical assistants and nurse practitioners to perform procedures unsupervised.

Another contracting official who was a co-conspirator in the scheme pleaded guilty and is serving a prison term.

30. *August 13, Softpedia* – (International) **iOS malware hijacks revenue from 22 million ads.** A researcher published a paper detailing the operation of the AdThief (also known as Spad) malware that infected around 75,000 jailbroken iOS devices and stole ad revenue from around 22 million ads. The researcher found that the revenue was diverted to the attackers using a Cydia Substrate extension to modify the ads developer ID to one used by the attackers.

36. *August 12, Dark Reading* – (International) **Security holes exposed in Trend Micro, Websense, open source DLP.** Two researchers from Duo Security and Tumblr presenting at the Black Hat conference reported identifying several cross-site scripting (XSS) and cross-site request forgery (CSRF) vulnerabilities in four commercial data loss prevention (DLP) products and one open-source DLP product that could allow attackers to access or manipulate data. The majority of the flaws were in the products' Web-based interfaces.
