### Top Stories

- Nine people were injured in multiple collisions involving about 50 vehicles on Interstate 82 near Kennewick, Washington, August 30 due to a dust storm which shut down the interstate for several hours while authorities investigated. – *Kennewick Tri-City Herald* (See item [10](#))

1. *August 28, Kennewick Tri-City Herald* – (Washington) **DOE agrees to pay \$23.6M to Energy Northwest.** The U.S. Department of Energy agreed to pay Energy Northwest around \$23.6 million in damages for failing to provide for the disposal of used nuclear fuel that was agreed to in 1983. The agreement covers used fuel storage costs at the Columbia Generating Station near Richland between August 2006 and June 2012. 2. *September 1, IDG News Service* – (International) **Rigged industrial software site points to watering hole attack.** Researchers at AlienVault reported that the Web site of an unnamed industrial software company was compromised with a piece of reconnaissance malware called Scanbox that collected information on visitors to the site, including visitors' IP addresses, language, operating system, and security programs. The unnamed company produces system engineering and simulation software for several industries including manufacturing, automotive, and aerospace firms. 3. *September 1, KNBC 4 Los Angeles* – (National) **“AK-47 Bandit” wanted in SoCal bank robberies suspected in Nebraska heist.** The FBI stated that the man responsible for the August 22 robbery of a First National Bank branch in southeast Nebraska matched the description of a suspect known as the “AK-47 Bandit” wanted in connection with several bank robberies in California, Washington, and Idaho beginning in 2012. The suspect was seen in bank robberies wielding an assault rifle and was involved in the shooting of a Chino, California police officer during a February 2012 robbery.

5. *September 2, WKMG 6 Orlando* – (Florida) **Big rig driver in Lake Mary I-4 crash fell asleep at wheel, Florida troopers say.** Interstate 4 near Lake Mary Boulevard was closed for more than 3 hours when a semi-truck overturned on eastbound lanes after the driver crashed into a guardrail September 2.

The man surrendered after being shot and injured by an officer and was taken to a nearby hospital.

## **Food and Agriculture Sector**

13. *September 1, Food Safety News* – (Idaho) **State halts raw milk sales from Idaho dairy.** The Idaho Department of Agriculture ordered Treasured Sunrise Acres in Parma, Idaho, to halt sales of raw goat and cow milk until further notice after milk from the dairy tested positive for *Cryptosporidium* during the week of August 25. Two individuals were reportedly sickened after they consumed raw goat milk from the dairy.

14. *August 31, Portland Press Herald* – (Maine) **State: Recalled beef was handled improperly.** Bubier Meats issued a voluntary recall August 29 of roughly 25,000 pounds of beef from its Greene, Maine slaughterhouse after the spinal column tissues were not removed potentially allowing the transmission of bovine spongiform encephalopathy (BSE). Maine health officials detected the issue during a routine review of the company's slaughter logs.

15. *August 30, Associated Press* – (Minnesota) **Cabbage likely caused Minnesota E. coli outbreak.** Minnesota Department of Health officials reported August 29 that green whole head cabbage was likely the source of an E. coli outbreak that sickened 15 individuals in July. Officials believe the cabbage was contaminated before the out-of-State supplier distributed it to at least 10 restaurants across Minnesota.

16. *August 29, U.S. Food and Drug Administration* – (National) **4C Foods Corp. voluntarily recalls 4C Grated Cheese HomeStyle Parmesan because of Salmonella contamination.** 4C Foods Corp., issued a recall August 29 for 308 cases of its 6-ounce containers of 4C Grated Cheese HomeStyle Parmesan due to possible Salmonella contamination. The recall was initiated after routine testing by the U.S. Food and Drug Administration revealed the potential risk for contamination.

17. *August 29, U.S. Environmental Protection Agency* – (Nebraska) **Settlements with pair of related Norfolk, Neb., pesticide companies to improve pesticide safety and reliability.** Norfolk-based Earthworks Health LLC and Customer Feed Services Corp., which have common ownership, entered into an agreement with the U.S. Environmental Protection Agency (EPA) August 29 and will pay \$74,513 in penalties to settle allegations that the companies produced and sold unregistered and misbranded pesticides. A November 2011 investigation by the Nebraska Department of Agriculture on behalf of the EPA, found both companies out of compliance with federal regulations for the production and sale of copper sulfate and diatomaceous earth pesticides.

18. *August 29, U.S. Food and Drug Administration* – (National) **Kraft Foods Group voluntarily recalls select varieties of regular Kraft American Singles Pasteurized Prepared Cheese Product due to ingredient supplier's out-of-standard storage temperatures.** The U.S. Food and Drug Administration announced August 29 that Kraft Foods Group issued a recall for 7,691 cases of 4 varieties of its regular Kraft American Singles Pasteurized Prepared Cheese Products due to the use of a supplier-provided ingredient that was not stored in accordance with Kraft's temperature standards. The affected product was produced at Kraft's Springfield, Missouri manufacturing facility and shipped to customers across the U.S.

19. *August 31, WZVN 26 Naples* – (Florida) **Boil water advisory for Burnt Store utilities service area.** Charlotte Country Utilities issued a precautionary boil water advisory for Burnt Store Utilities' customers across several areas August 31 until further notice due to a failure at the Burnt Store water treatment plant.

20. *August 29, Sioux City Journal* – (Iowa) **Company fined \$54,000 for dumping waste water in Sioux Center.** Orange City-based Sioux-Preme Packing Co., agreed to pay \$54,000 in penalties and an additional \$23,000 after the company admitted to violating several environmental regulations when it released an illegal volume of waste water into a tributary of the West Branch Floyd River that killed an estimated 190,000 fish in October 2012.

Patients' were notified that their names, dates of birth, addresses, and some Social Security numbers were viewed in the breach.

Users found that only individuals running Windows 8.1 appeared to be affected and that syncing OneDrive to a computer running Windows 7 would make the files accessible again.

The new variant uses the Tor network for command and control communications and can perform actions including downloading and uploading files, deleting content, and performing actions as the infected user.

34. *August 29, SC Magazine* – (International) **Syrian Malware Team makes use of enhanced BlackWorm RAT.** FireEye researchers reported that a hacktivist group known as the Syrian Malware Team has used an enhanced version of the BlackWorm remote access trojan (RAT) known as “Dark Edition” in its campaigns. The new variant allows attackers to bypass user account control (UAC) features, spread itself over network drives, and disable firewalls.
