1. September 8, Oakland Press – (Michigan) 21K still without power in Oakland County, DTE estimates restoration by Monday night. DTE Energy crews worked to restore power to the remaining 21,000 customers in Oakland County September 8 that lost service after strong storms September 5 knocked out power to approximately 385,000 customers in southeast Michigan.

4. September 6, Richmond Times-Dispatch – (International) Fredericksburg man accused of mail and wire fraud. A Fredericksburg, Virginia man was charged in a complaint September 5 with allegedly making fraudulent investment offerings to investors in several countries in order to obtain over \$35 million in investments purported to be part of the Quantico Corporate Center project. The man allegedly used the funds for several other purposes including diverting them to a day-trading account where he lost over \$14 million.

Westbound lanes of Interstate 91were expected to be closed for hours due to the incident.

- 8. September 5, Seattle Times (Alaska) Alaska Airlines pays \$500k penalty over electrical fire. The U.S. Attorney's Office announced September 5 that Alaska Airlines agreed to pay \$500,000 in civil penalty claims after an electrical fire ignited in the cockpit of a Boeing 737-400 in 2010 while the plane was parked at a gate in an

Anchorage airport due to an improperly positioned metal clamp. A Federal Aviation Administration investigation also found 9 additional airplanes with incorrectly installed metal clamps attaching an air hose to cockpit overhead panels.

10. September 8, U.S. Food and Drug Administration – (National) Mars Chocolate North America issues allergy alert voluntary recall on undeclared peanuts and eggs in TWIX Bites 7oz stand up pouch. Mars Chocolate North America announced a voluntary recall for less than 25 cases of TWIX Brand Unwrapped Bites 7oz Stand Up Pouch products after undeclared peanuts and egg were detected following a consumer notification. The affected products were distributed to customers' warehouses in Connecticut, Indiana, Oregon, Tennessee, and Texas.

- 11. September 6, Food Safety News (National) Perdue recalls raw chicken for possible temperature processing problem. Perdue Foods announced a recall of around 720 pounds of raw, fresh chicken products after employees found that potable water was used instead of chill water in a facility's chiller, creating variations in product temperature. The recalled products were shipped to a New York distributor for resale and food service used in New York, Connecticut, New Jersey, and Pennsylvania. Officials are investigating the cause of the fire and staff and patients will be temporarily reassigned to other clinics in the area.

The malicious extension circumvents Google's security policy against non-Chrome Web Store apps by creating a folder in the browser directory where it then drops its components. About 50 residents were displaced and the cause of the fire is under investigation after records found the building failed several inspections in the last 9 years.
