## Energy Sector

1. *September 22, Lancaster Intelligencer Journal/Lancaster New Era* – (Pennsylvania) **Cause of 3-alarm fire at Burle electrical substation still unknown.** A 3-alarm fire at a Burle Industries-owned electrical power station in Lancaster prompted the evacuation of the facility and surrounding buildings while fire crews contained and put out the fire September 21. Authorities are investigating the cause of the explosion that left an estimated \$25,000 in damage.

2. *September 21, August Chronicle* – (Georgia) **128 gas pumps in Augusta area cited for defects in past 5 years.** A Georgia Department of Agriculture inspection report determined that 128 gas station pumps throughout Richmond, Columbia, Burke, and McDuffie counties were cited for violations ranging from leaky hoses to faulty dispensers from 2010 to 2014. Over 73 pumps were shut down region-wide since 2010 due to the defects.

Authorities reported to the site to inspect the affected wheat field and wetland.

5. *September 20, Detroit News* – (International) **Chrysler recalls 230,000 SUVs for fuel pump issue.** Chrysler Group LLC announced a recall for 230,760 model year 2011 Jeep Grand Cherokee and Dodge Durango vehicles, including an estimated 188,723 in the U.S., due to the potential for the fuel pump to fail which could cause the vehicles to fail to start, to stall, or could result in the fuel pump staying energized after shutdown.

6. *September 20, Detroit News* – (International) **GM recalls 221,000 cars for braking problem.** General Motors Co., announced a recall September 20 for 221,000 model year 2013-2015 Cadillac XTS and model year 2014-2015 Chevrolet Impala vehicles, 205,000 of which are in the U.S., due to the potential for the vehicles' electronic parking brake's piston actuation arm to fail to fully retract, which could cause the brake pads to remain partially engaged to the rotors resulting in excessive heat and poor performance.

7. *September 19, Associated Press* – (Texas) **8 employees, 1 other charged in theft of diesel injectors from Texas Caterpillar plant.** Police in Seguin arrested 8 Caterpillar employees and one other individual September 19 for allegedly stealing 107 diesel injectors worth at least \$160,000 from a Texas Caterpillar plant. Police and Texas Rangers stated that the suspects allegedly started stealing equipment from the plant in July.

9. *September 19, Reuters* – (National) **U.S judge awards \$40.7 million in SEC case over bitcoin Ponzi scheme.** A federal judge ruled September 18 that a Texas man who operated Bitcoin Savings and Trust operated a Ponzi scheme that defrauded investors and ordered the man to pay \$40.7 million following U.S. Securities and Exchange Commission charges of investment fraud. The scheme raised investments using the Bitcoin virtual currency between February 2011 and August 2012 on the promise of weekly returns but the funds were instead used for the owner's personal expenses.

The man allegedly conveyed information between a law firm managing clerk and a stockbroker in order to trade on nonpublic information for the benefit of the three parties.
