1. *September 30, West Virginia MetroNews* – (West Virginia) **DEP halts a drilling operation in Doddridge County after accident.** The West Virginia Department of Environmental Protection ordered operations on the Primm Pad near West Union to halt September 30 after Antero Resources notified the agency of a gas influx September 23 when the drill for the Stella 1h well collided with the Callie 2h well causing a release of methane gas. Four personal wells and two existing gas wells were found to have been affected in an initial investigation.

2. *September 30, Waco Tribune-Herald* – (Texas) **Officials investigate repeated blazes at paint recycling plant.** Officials are investigating a suspected electrical fire that broke out inside a recycling area of the Southern Enterprises of Envirocare paint recycling facility near Bruceville-Eddy September 30, causing some paint thinner to ignite and produce a black cloud of smoke above the facility. A shelter-in-place order for schools in the area was lifted after about 2 hours.

3. *September 30, Associated Press* – (New Mexico) **\$240 million WIPP recovery plan aims at 2016 reopening.** The U.S. Department of Energy released a recovery plan for the Waste Isolation Pilot Plant (WIPP) in New Mexico designed to clean up the nuclear waste facility and resume operations as early as 2016. The recovery plan estimates a cost of \$240 million to \$549 million for the facility.

4. *September 30, Associated Press* – (Washington) **Large fire burns, releases chemicals in Seattle.** A large fire destroyed a manufacturing facility housing a metal finishing company and a metal etching company in Seattle September 30. Both firms generate a large quantity of hazardous chemical waste and a chemical containment team was

working to collect water from the firefighting efforts for safe disposal.

5. *September 30, U.S. Securities and Exchange Commission* – (International) **Court imposes injunctions and monetary sanctions of nearly \$30 million against former CEO and CFO of Electronic Game Card.** A federal judge issued an order imposing \$29.6 million in sanctions against the former CEO and CFO of Electronic Game Card based on U.S. Securities and Exchange Commission charges that the two individuals allegedly used fraudulent means and fake contracts to increase the value of the now bankrupt company's stocks. The two allegedly used entities based in Gibraltar that they secretly controlled to sell shares and collect more than \$12.3 million in proceeds.

6. *September 30, KSWB 5 San Diego* – (California) **Couple pleads guilty to real estate investment fraud.** A San Diego real estate investor and his wife pleaded guilty September 30 for their role in a mortgage fraud scheme that caused between \$2.5 and \$20 million in losses and tax fraud. The couple recruited straw buyers, inflated the value of properties, disguised the sources of down payments, and hid skimmed profits from the Internal Revenue Service.

7. *September 30, Bay City News Service* – (California) **Foster City man sued by SEC for alleged fraud in ATM investment scam.** A Foster City man and his company Transactions Unlimited, operating as ATM Plus, was charged September 29 by the U.S. Securities and Exchange Commission for allegedly operating the company as a Ponzi scheme that obtained around \$12 million from 160 investors using fraudulent statements and documents. The man was also previously indicted by the Santa Clara County District Attorney's Office on several fraud and theft charges.

8. *October 1, Long Island Newsday* – (New York) **Police: Long Island Expressway reopens in Jericho after accident.** Eastbound lanes of the Long Island Expressway in Jericho reopened to traffic October 1 after being closed for more than 6 hours following a multivehicle crash that resulted in a fuel spill. Two people suffered minor injuries but did not need to be hospitalized.

9. *September 30, Reuters* – (National) **U.S. orders airlines to replace cockpit displays on 1,300 Boeing airplanes.** The U.S. Federal Aviation Administration ordered airlines to replace cockpit display units made by Honeywell International Inc. on more than 1,300 Boeing 737 and 777 aircraft due to concerns of inference from Wi-Fi, cellular devices, radar, and satellite communications. The replacement of all Honeywell unit displays within 5 years is estimated to cost nearly \$14 million.

10. *September 30, WITI 6 Milwaukee* – (Wisconsin) **Fatal wreck that shut down all lanes of US 45 SB cleared, lanes reopen to traffic.** One person was killed when two cars collided on US Highway 45 in Milwaukee September 30 and shut down a portion of southbound lanes for nearly 6 hours.

12. *September 29, KSNV 3 Las Vegas* – (Nevada) **I-15 repairs to take 2 weeks and cost \$1.4 million.** A Nevada Department of Transportation official stated that it could take up to 2 weeks and cost \$1.4 million to complete repair work on Interstate 15 in the Mesquite area that was damaged by heavy rains and flooding September 26.

16. *October 1, WFIE 14 Evansville* – (Indiana) **Fire crews put out Gibson Co. grain bin fire.** Firefighters extinguished a fire that broke out September 30 inside a grain bin holding about 75,000 bushels of corn at a Wabash Valley Grain facility in Gibson County. Residents in the area were informed of a voluntary evacuation due to the possibility of an explosion caused by grain vapors.

Authorities asked for the public's help in finding the responsible parties.

18. *September 30, WAFF 48 Huntsville* – (Alabama) **Cameras aid in arrest of brothers accused of stealing farm equipment.** Three brothers were arrested and charged for their involvement in a theft ring which netted more than \$7,500 worth of farm equipment and scrap metal from farms in Colbert County, including one farm that was targeted at least 6 times.

19. *September 30, U.S. Department of Agriculture* – (Texas) **Recall notification report 063-2014 (Ground Beef Chub).** The Food Safety and Inspection Service announced September 30 that Sam Kane Beef Processors, LLC, issued a recall for about 2,633 pounds of ground beef chub product due to the possibility that it may contain blue plastic particles caused by a manufacturing error that involved a rubber glove. The product was distributed to retailers in Texas for further processing.

An investigation by authorities revealed that heavy rains overwhelmed Case Farms' treatment system causing storm water and chicken parts to flow from the chicken processing facility into the city's sewer system.

21. *October 1, Associated Press* – (Tennessee) **Tenn. city fined for dumping raw sewage in river.** The city of Sneedville was issued \$101,000 in fines by the Tennessee Department of Environment and Conservation for dumping raw sewage into the Clinch River between January 2014 and May 2014. The city's mayor stated that the city contracted a plant operator and is making repairs to the city's sewage system.

The company allegedly discharged untreated wastewater into the city of Council Bluff's wastewater collection system between April 2007 and April 2008 illegally and violated its stormwater permit in March 2011.

35. *October 1, V3.co.uk* – (International) **Four hackers accused of \$100m US military software and gaming IP theft.** Four individuals were indicted for allegedly stealing over \$100 million worth of intellectual property from game developers and the U.S. Army including data from yet-to-be-released games and training software used to train helicopter pilots. Two of the accused pleaded guilty and reportedly used a SQL injection attack to steal the usernames and passwords of employees and software developers in order to gain access to the data.

36. *October 1, Softpedia* – (International) **Xsser mRAT, advanced spyware for iOS, discovered.** Researchers with Lagoon Mobile Security identified a new remote access trojan (RAT) for iOS mobile devices dubbed Xsser that targets jailbroken iOS devices and can exfiltrate personal and device data. The researchers believe that Xsser is linked to the Chinese government and targets protestors in Hong Kong.

38. *September 30, The Register* – (International) **OpenVPN open to pre-auth Bash Shellshock bug - researcher.** The chief technology officer of Mullvad stated that some configurations of OpenVPN are susceptible to the Shellshock vulnerability if Bash is allowed to run scripts. A proof-of-concept for the issue was identified online.

39. *September 30, Softpedia* – (International) **Asprox botnet malware sent through fake Viber email notification.** An analysis from Tech Help List identified a new spam campaign utilizing fake Viber emails to attempt to add new bots to the Asprox botnet.

The analysis noted that the attackers were using several techniques to hide their malicious activity and avoid analysis by researchers.
