- The U.S. Postal Service announced November 12 that it has shut down its secure virtual private network (VPN) and suspended all telecommuting for employees at its Washington, D.C. headquarters until further notice. *USA Today* (See item <u>13</u>)
- Visionworks announced November 10 that a computer server containing information on about 75,000 customers went missing from its store in Annapolis, Maryland, during a June store remodeling. *Harrisburg Patriot-News* (See item 19)
- Officials announced November 12 that Illinois' motor vehicle facilities will reopen November 13 following a computer outage that impacted operations at all 138 offices. – Associated Press (See item <u>21</u>)
- Police are investigating potential links between bomb threats that were called into 5 different schools and public buildings in 5 different New Jersey towns November 12, after similar threats were made to 5 schools in the Boston area. WNBC 4 New York City (See item 23)

1. November 11, Muncie Star Press – (Indiana) Cardinal Ethanol fined \$9,600. Cardinal Ethanol paid a \$9,600 fine to settle a complaint by the Indiana Department of Environmental Management claiming that the company violated its Clean Air Act operating permit by not taking reasonable steps to restore an air pollution scrubber's operation to normal operation during planned shutdowns in 2011-2013 at its east central Indiana plant.

November 13, U.S. Environmental Protection Agency – (Pennsylvania) EPA settlement with Mack Trucks Inc. protects community health and the environment from hazardous waste pollution in Lehigh County, PA. Mack Trucks Inc., reached a settlement with the U.S. Environmental Protection Agency (EPA), agreeing November 13 to pay a \$54,800 penalty and take steps to properly manage hazardous waste at its Macungie truck assembly facility following EPA citations for violating the Resource Conservation and Recovery Act.

3. November 13, U.S. Consumer Product Safety Commission – (International) Venmar Ventilation expands recall of air exchangers due to fire hazard. Venmar Ventilation announced the expansion of a recall of air exchangers sold under various brand names November 13, adding around 108,000 units in the U.S. and around 207,000 in Canada due to the potential for the units' motors to overheat, posing a fire hazard. Previous recalls covered 77,500 units during 2007 and 2011.

### Air-Exchangers/

- 4. November 13, U.S. Consumer Product Safety Commission (International) Tankless water heaters recalled due to fire hazard; manufactured by Daesung Celtic Enersys; distributed exclusively by Challenger Supply Holdings. Daesung Celtic Enersys announced a recall November 13 for about 29,000 tankless water heaters in the U.S. and 2,200 in Canada due to the potential for the water heaters to overheat, posing a fire hazard. The water heaters were sold exclusively through Challenger Supply Holdings and sold through independent dealers and on various Web sites. - 5. November 12, U.S. Department of Labor (Wisconsin) Workers cleaning chemical spill at Portage, Wisconsin, plastics plant lacked training, personal protective equipment. Penda Corp., was fined \$49,000 and cited for 7 safety violations by the Occupational Safety and Health Administration (OSHA) following the September 5 spill of 100 gallons of diphenylmethane diisocyanate at the company's Portage facility. An OSHA investigation revealed that workers were overexposed to the isocyanates chemical due to inadequate training in cleanup procedures of a HAZMAT spill and the lack of proper personal protective equipment.

November 13, WTVA 9 Tupelo – (Mississippi) **Highway 82 open after tanker spill.** A semi-truck carrying anhydrous ammonia prompted the shutdown of Highway 82 in Mathiston November 12 after a pressure pump valve came off and vapor was released. The highway reopened November 13 following the evacuation of homes within a half mile radius.

10. *November 13*, *WMTW 8 Poland Spring* – (Maine) **Tanker truck crashes in Porter, spills gasoline.** About 2,500 gallons of gasoline spilled after a semi-truck hit a sharp drop-off edge of pavement before going down a ditch on Route 25 in Porter November 12, forcing the roadway's closure. Route 25 reopened November 13 while crews continued cleanup efforts.

The rescue was completed about 2 hours later and no injuries were reported.
