Top Stories

- Around 131,000 homes in New Hampshire were without power November 28 following a snowstorm the caused outages to over 200,000 customers late November 26. Associated Press (See item 1)
- The Madison Metropolitan Sewerage District in Wisconsin reported November 26 that approximately 500,000 gallons of untreated wastewater was discharged over a 25-hour period when three pumps failed November 16. *Wisconsin State Journal* (See item 14)
- A gunman was fatally shot November 28 after he fired more than 100 shots at government buildings in downtown Austin, Texas, including the federal courthouse and the police department's headquarters as well as attempting to set fire to the Mexican consulate. NBC News (See item 16)
- Researchers identified a new point of sale (PoS) malware dubbed DareDevil, designed to steal payment card information from multiple PoS systems. *Softpedia* (See item <u>26</u>)

- 1. November 28, Associated Press (New Hampshire) N.H. hit hard by storm-related power outages. Around 131,000 customers in New Hampshire were without power November 28 following a snowstorm the caused outages to over 200,000 customers late November 26. - 2. November 27, Springfield Republican (Massachusetts) Nearly 19,000 Western Massachusetts power customers coping with Thanksgiving power outages. Heavy snowfall caused around 19,000 customers mainly in Berkshire and Franklin counties to lose power November 26-27. Crews worked to restore power and utilities and reported that they hoped to restore power to most customers by later that day. Source:

3. November 28, WMTW 8 Poland Spring – (Maine) CMP deploys hundreds to restore power lost in holiday storm. A snowstorm November 26 in Maine brought down trees and power lines causing customers to lose power mainly in Cumberland and York counties. Utilities reported that over 25,000 customers remained without power as of November 28.

- 4. November 28, Bergen County Record (New Jersey) Feds seeking damages against DuPont for contamination in Pompton Lakes. DuPont and the U.S. Fish and Wildlife Service entered into a cooperative agreement to determine the extent of damage to fish, wildlife, and other natural resources from pollution at the company's now defunct Pompton Lakes ammunition production facility. DuPont agreed to pay for a portion of the agency's research and to collaborate during the information-gathering process of the investigation.

- 5. November 27, Richmond Times-Dispatch (Virginia) Chemical spill apparently caused Hopewell fish kill. Virginia Department of Environmental Quality officials reported that a fish kill in Gravelly Run creek appears to be connected to the spill of about 5,500 pounds of ammonium carbonate at the Honeywell International facility in Hopewell November 24. Authorities reported that all but 600 pounds of the chemical was contained in a treatment lagoon and the remainder of the chemical flowed into the creek.

Dallas were reopened to traffic after being closed for nearly 6 hours when a diesel tank ruptured and spilled fuel onto the highway during a semi-truck accident November 26. 14. November 27, Wisconsin State Journal – (Wisconsin) Madison Metropolitan Sewage District reports 500,000-gallon spill in mid-November. The Madison Metropolitan Sewerage District reported November 26 that approximately 500,000 gallons of untreated wastewater was intermittently discharged over a 25-hour period on Madison's north side November 16 when the primary pump and 2 backup pumps failed while a contractor was in the process of relining the interceptor sewer and diverting the wastewater.

16. November 28, NBC News – (Texas) Gunman dead after shots fired at police HQ, Mexican consulate in Austin. A gunman fired more than 100 shots in downtown Austin November 28 targeting a federal courthouse, the Mexican consulate, and the police department's headquarters, and then attempted to set fire to the consulate. Authorities shut down Interstate 35 for more than 3 hours while they investigated the death of the gunman and suspicious devices that were found in the suspect's vehicle and attached to the suspect's body.

17. November 26, San Jose Mercury News – (California) Saratoga: West Valley College evacuated, classes canceled after threat made to campus. West Valley College in Saratoga was evacuated and closed November 26 due to a threat that was deemed credible after administrators and police reviewed an anonymous note given to staff that claimed the author overheard a conversation involving a threat to the campus. Police searched the campus for at least 4 hours and found nothing to substantiate the threat, while classes were expected to resume December 1 after the conclusion of the previously-scheduled Thanksgiving holiday.

The creators of the Gigya comment platform announced that they closed a vulnerability in the product that allowed attackers claiming affiliation with the Syrian Electronic Army hacktivist group to place pop-up messages on the Web sites of several major technology, news, and other entities November 27. 26. November 27, Softpedia – (International) New DareDevil PoS malware also infects ticket machines and electronic kiosks. Researchers with IntelCrawler identified a new piece of point of sale (PoS) malware dubbed DareDevil that has been found affecting several PoS products including Figure Gemini PoS, Harmony WinPOS, OSIPOS Retail Management System, and QuickBooks Point of Sale Multi-Store and includes features such as backdoor access, keylogging, and RAM scraping. The malware was also found to be targeting PoS systems on mass transit system ticket kiosks.
