Top Stories

- Honda announced December 3 that it will expand its recall of vehicles equipped with airbags manufactured by Takata to include all 50 States due to the potential for the airbag inflators to shatter and send shrapnel into vehicles' cabins. Washington Post (See item 4)

1. December 4, New Orleans Times-Picayune – (Louisiana) BP oil spill claims adjuster pleads guilty to \$257,400 wire fraud. A former LaPlace adjuster for the Gulf Coast Claims Facility pleaded guilty December 3 to filing 6 fraudulent claims totaling \$257,400 in exchange for keeping \$30,000 for individuals who were not impacted by the 2010 BP oil spill. The former adjuster recruited people to pose as commercial fishing workers who lost their jobs or income due to the spill in order to file the false claims.

2. December 3, San Luis Obispo Tribune – (California) NRC tentatively downgrades safety designation at Diablo Canyon. The U.S. Nuclear Regulatory Commission informed the operators of the Diablo Canyon nuclear power plant the week of December 1 that it was tentatively downgrading the plant's safety designation from 'green' to 'white' due to unauthorized changes in the plant's emergency warning procedures for boats 5-10 miles offshore.

The cause of the shutdown was being investigated and posed no threat to the public or electrical power distribution.

The announcement could result in the recall of several million vehicles.

- 6. December 4, Softpedia (International) Critical PayPal bug left all accounts vulnerable to hijacking. A security researcher identified and reported a cross-site request forgery (CSRF) vulnerability that could have been used with other flaws to allow an attacker to link their email address to a victim's account by capturing a reusable authentication token that was valid for all PayPal accounts. The vulnerability was fixed by PayPal before the researcher publicly disclosed his findings, and the researcher was awarded \$10,000 from PayPal's Bug Bounty program.

- 7. December 3, Tribune News Service (Florida) Investigation reveals how Florida man ripped off DEA. A report from the U.S. Department of Justice's Office of the Inspector General found that a now-deceased Jacksonville man who ran the FEBG Bond Fund operated the fund as a Ponzi scheme that defrauded around 130 individuals of over \$30 million, more than half of whom were current or former Drug Enforcement Agency (DEA) employees or connected to DEA employees. The report found that some DEA personnel exercised poor judgment in giving the man access to DEA personnel and facilities and receiving gifts from the man.

- 8. December 3, Charlotte Observer (North Carolina; South Carolina) Charlotte man

pleads guilty to role in Wax House scheme. A Charlotte, North Carolina man pleaded guilty December 3 for his role in the \$75 million Operation Wax House mortgage and investment fraud scheme in North Carolina and South Carolina. The man was charged with laundering over \$200,000 in loan proceeds through his Perry Masonry Construction company and for working as a promoter to recruit straw buyers. Route 422 West in North Coventry Township was shut down for 5 hours as authorities investigated after a construction worker was struck and killed by a vehicle while setting up traffic cones for a lane closure and line painting December 3.

10. December 3, WCBS 2 New York City – (New York) \$20,000 in loot allegedly taken from checked luggage by JFK bag handlers. Seven bag handlers at John F. Kennedy International Airport in New York City were arrested December 3 and indicted for allegedly stealing electronics, jewelry, and other items from checked baggage at Terminals 4 and 7 between March 2012 and June 2014 with the total value of stolen goods estimated at over \$20,000.

- 12. *December 3*, *New York Daily News* (New York) **Postal workers on Long Island busted for stealing pot packages.** Eight workers at a U.S. Postal Service processing center in Bethpage were charged December 3 on federal charges for allegedly stealing illegal shipments of marijuana and conspiring to deal the drugs. Federal agents seized 129 pounds of marijuana with an estimated street value of up to \$930,000. Officials are investigating a December 3 fire at the PepsiCo-owned Quaker Oats production facility in Columbia, Missouri, that is believed to have started in a rice cake processing machine and was contained by an automatic sprinkler system that was activated during the blaze. The factory was evacuated and closed for about 2 hours, while one employee was treated at the scene for minor injuries.

14. December 3, Reuters – (Idaho) Idaho authorities seek missing cows amid rise in cattle rustling. Authorities are investigating after 66 cow-calf pairs, a total of 132 animals, were reported missing from 2 grazing allotments near Idaho Falls during the week of December 1. The Idaho State Brand Inspector reported that while there is reason to believe the cattle may have been stolen there is a possibility that the animals may have roamed and joined herds grazing nearby and were inadvertently herded by other ranchers.

December 3, U.S. Food and Drug Administration (National) Overhill Farms voluntarily recalls Open Nature Chile Cheese Enchiladas sold at Safeway stores nationwide due to possible Salmonella contamination. The U.S. Food and Drug Administration announced December 3 that Overhill Farms, Inc., issued a recall for its Open Nature Chile Cheese Enchiladas after a third party supplier informed the company that the organic cilantro contained in the frozen food product may be contaminated with Salmonella. - 16. December 2, Racine County Journal Times (Wisconsin) Grain bin corn flares up again. A fire broke out December 1 within the outside dryer portion of a grain bin at a farm in Mount Pleasant, Wisconsin, and caused between \$30,000 and \$50,000 in damage to the silo and the drying fan that was rendered a total loss. Firefighters returned to the scene December 2 after receiving reports of another corn fire flare-up where some of the corn in the drying floor needed to be cooled with water. 29. *December 3*, *Softpedia* – (International) **Vulnerability in WhatsApp leads to losing conversations.** Two security researchers reported and released a proof-of-concept (PoC) for a flaw in WhatsApp where an attacker could send a 2KB text containing special characters that would cause the app to crash unless the conversation thread is deleted. The researchers stated that the app affects WhatsApp versions 2.11.431 and 2.11.432 on Android devices.

- 30. December 3, Securityweek (International) DNSimple suffers downtime due to 25 Gbps DDoS attack. Florida-based DNS provider DNSimple reported that it experienced a distributed denial of service (DDoS) attack December 1 that peaked at 25 Gbps and lasted around 12 hours, causing outages for the company and its customers. The company stated that DNSimple was not targeted but was affected by the DDoS attack after domains already under attack were delegated to the company.
