1. *August 29, TheCarConnection.com* – (National) **2007-2012 Mazda CX-7 recalled for corrosion problem.** Mazda Motor Corporation issued a recall August 29 for 190,102 of its model years 2007 – 2012 Mazda CX-7 crossover vehicles sold in the U.S. due to a potential corrosion issue where water entering the front suspension ball joint fittings can cause the ball joint fittings to corrode and the front lower control arm to separate from the vehicle, thereby making the vehicle more difficult to steer and increasing the risk of an accident.

2. *August 30, WBIW 1340 AM Bedford* – (Indiana) **Martinsville man killed after being struck by semi.** Northbound lanes of Indiana State Route 37 in Martinsville, Indiana, were closed for more than 2 hours August 28 after a pedestrian was fatally struck by a semi-truck while crossing the interstate near the Indiana 252 intersection.

3. *August 30, KFVS 12 Cape Girardeau* – (Missouri) **3 taken to hospital after car hits people pushing car along I-55.** Northbound Interstate 55 in Cape Girardeau, Missouri, was closed for nearly 2 hours August 30 while officials investigated the scene after vehicle struck 2 pedestrians that were pushing their broken down vehicle on the roadway, sending 3 people to an area hospital with injuries.

4. *August 29, San Francisco Bay City News* – (California) **Fatal crash blocks portion of Foothill Expressway in Los Altos.** Eastbound lanes of Foothill Expressway between St. Joseph Avenue and Loyola Drive in Los Altos, California, were closed for several hours August 29 while officials investigated the scene of a fatal single-vehicle crash. El Monte Road and Interstate Highway 280 were used as alternative routes during the investigation.

5. *August 29, KWBE 1450 AM Beatrice* – (Nebraska) **One dead, two hospitalized in Highway 75 crash in Nemaha County.** Highway 75 in Peru, Nebraska, was closed for approximately 3 hours August 29 while crews worked to clear the wreckage from a fatal 2-vehicle crash involving a semi-truck and another vehicle that left 1 person dead and injured 2 others.

6. *August 29, KITV 4 Honolulu* – (Hawaii) **Napo’opo’o road closure.** Officials closed Napo’opo’o Road near Kahau Place in South Kona, Hawaii, for several hours August 29 while crews worked to remove a downed utility pole from an earlier traffic accident.

7. *August 29, KXRO 1320 AM Aberdeen*– (Washington) **DUI and reckless driving the cause of Westport Highway backup.** Authorities cited a Westport, Washington resident for driving under the influence and reckless driving August 26 following a 2-vehicle accident that forced the closure of both directions of Washington State Route 105 in Westport for more than 2 hours while officials investigated the accident. One person was sent to an area hospital with injuries.

8. *August 29, Associated Press; KXAS 5 Fort Worth* – (Texas) **U.S. 377 reopens after train derailment in Roanoke.** U.S. 377 in Roanoke, Texas, reopened August 29 after being closed for several hours at a time the week of August 22 while crews worked to replace 1,600 feet of rail that was damaged when a Union Pacific train derailed near the 3000 block of North U.S. 377 August 21.

9. *August 29, KIRO 7 Seattle* – (Minnesota) **Man taken off Seattle-bound flight after trying to open door mid-air.** Alaska Airlines Flight 7 en route to Seattle-Tacoma International Airport in Seattle, Washington, from John F. Kennedy International Airport in New York was forced to make an emergency landing at Minneapolis-Saint Paul International Airport in Minneapolis, Minnesota, August 29 after a passenger

attempted to open the plane's doors mid-air. The flight resumed after the passenger was removed from the plane and transported to a hospital in Edina, Minnesota.

12. *August 29, U.S. Food and Drug Administration* – (National) **Impax Laboratories, Inc. issues voluntary, nationwide recall for one lot of Lamotrigine Orally Disintegrating Tablet 200 mg due to the potential for 100 mg blister cards being packaged in 200 mg containers.** Impax Laboratories, Inc. issued a voluntary recall August 29 for its Lamotrigine Orally Disintegrating Tablet products sold in 200-miligram (mg) packages due to mislabeling after it was discovered the blister packs may contain 100-mg tablets instead of 200-mg tablets. The affected packages were distributed to wholesale distributors and retail pharmacies nationwide.

13. *August 30, Redding Record Searchlight* – (California) **Gap Fire burns 8,820 acres in Klamath National Forest west of Yreka.** Crews worked August 29 to contain the 8,820-acre Gap Fire burning near Yreka, California, in the Klamath National Forest which has destroyed at least 9 structures, forced the evacuation of Horse Creek and Hamburg, and prompted the closure of Highway 96. The cause of the fire remains under investigation.

14. *August 30, KSBW 8 Monterey* – (California) **Soberanes fire grows to more than 93,000 acres.** Officials reported that the Soberanes Fire burning in Monterey County, California, grew to 93,245 acres August 30 while containment remained at 60 percent. Officials issued August 28 an evacuation warning for a small section of Monterey County along the Pacific Coast Highway and stated that the fire has destroyed 57 homes, threatens 400 more, and killed 1 person.

15. *August 29, KCPQ 13 Tacoma* – (Washington) **Beach at Lake Sammamish State Park being closed after up to 15 swimmers became sick.** Officials from Public Health of Seattle and King County in Washington closed Tibbetts Beach at Lake Sammamish State Park August 29 after up to 15 children became sick after swimming at the beach August 26. The cause of the illness remains under investigation.

16. *August 29, Cache Valley Daily* – (Utah) **Crews double containment on Peterson Hollow Fire.** Crews reached 22 percent containment August 28 of the 1,202-acre Peterson Hollow Fire burning near the Beaver Mountain Ski Resort in the Uinta-Wasatch-Cache National Forest in Utah. Officials stated an area closure is in effect on the Utah side of the State line and a trail closure remains in effect on the Idaho side.

17. *August 28, KSTU 13 Salt Lake City* – (Utah) **Black Hawk helicopters dispatched to assist crews fighting Box Canyon Fire.** Crews reached 20 percent containment August 27 of the 3,947-acre Box Canyon Fire burning in Summit County, Utah, which has prompted the response of the Utah National Guard and forced the closure of Ledgefork campground, Smith and Morehouse boat ramp, and Mud Lake Flats, among other areas.

18. *August 30, Softpedia* – (International) **New and mysterious FairWare ransomware targets Linux server.** A Bleeping Computer analyst reported that at least 3 Linux server administrators discovered that a ransomware variant, dubbed FairWare hacked their servers, removed their Website root folders, and left a ransom note in the /root

folder demanding a 2 Bitcoin, or roughly \$1,150, payment in order to retrieve the files. The researcher stated there is no evidence that the ransomware encrypts the user's files and warned FairWare may be deleting the files and scamming victims after the ransom is paid.

19. *August 29, SecurityWeek* – (International) **Kelihos botnet triples in size overnight.** MalwareTech researchers warned that the Kelihos botnet's activity significantly increased to 34,533 infections in August and discovered that the botnet was spamming other malware after finding that Kelihos was distributing Wildfire ransomware as well as banking trojans based on the Zeus source code. Researchers believe Kelihos started distributing ransomware and banking trojans after the botnet's operator realized the malware was more profitable than its original pump and dump spamming campaigns.
