- An emeritus professor in Rochester, New York, pleaded guilty November 4 for allegedly concealing \$200 million worth of assets from the U.S. Internal Revenue Service in offshore accounts at a Zurich, Switzerland-based bank. – *Bloomberg* (See item [2](#))

1. *November 7, Associated Press* – (Alabama) **An Alabama gas pipeline exploded, now back in service.** Colonial Pipeline Co. reopened its main gasoline line in Shelby County, Alabama, November 6 following a 6-day shutdown after an explosion killed 1 worker and injured 4 others October 31 when a piece of excavation equipment struck the pipeline. Colonial Pipeline officials announced that it will take several days for the fuel delivery to return to normal.

2. *November 4, Bloomberg* – (International) **Credit Suisse said to hold accounts for latest U.S. tax felon.** An emeritus professor in Rochester, New York, pleaded guilty November 4 for allegedly concealing \$200 million worth of assets from the U.S. Internal Revenue Service through offshore accounts at a Zurich, Switzerland-based bank, and filing false tax returns from 2008 – 2014 that failed to disclose his earnings from his Swiss bank accounts. The professor agreed to pay the U.S. Government a \$100 million penalty for neglecting to file Reports of Foreign Bank and Financial Accounts (FBARs) until 2011, including fraudulent ones from 2012 – 2013.

3. *November 7, WPLG 10 Miami* – (Florida) **4 injured in Hallandale Beach crash; I-95 closes at Pembroke Road exit.** Southbound lanes of Interstate 95 in Hallandale Beach, Florida, were closed for roughly 4 hours November 6 following a three-vehicle

- collision that injured four people. The cause of the crash remains under investigation.

4. *November 7, Southern California City News Service* – (California) **Motorcyclist killed on Harley after rear-ending OCTA bus.** A motorcyclist was killed after colliding with an Orange County Transportation Authority bus on the 55 Freeway in Orange County, California, November 6, prompting the closure of the northbound lanes for 2 hours.

 5. *November 7, WPRI 12 Providence* – (Massachusetts) **Police: 1 dead, 5 injured in Westport highway crash.** Interstate 195 eastbound in Westport, Massachusetts, was closed for several hours November 6 after a vehicle veered off the roadway and overturned, killing one person and injuring five others. The cause of the crash remains under investigation.

 6. *November 7, WTHR 13 Indianapolis; Paper of Montgomery County* – (Indiana) **Fire at Montgomery County Highway Dept. destroys nearly all of county's snow plows; \$3M damage.** Authorities are investigating the cause of a November 6 fire at the Montgomery County Highway Department's garage in Crawfordsville, Indiana, that destroyed 15 department vehicles and caused an estimated \$3 million in damage.

 7. *November 7, KRBC 9 Abilene* – (Texas) **Tractor trailer crash leads to fuel spill and road closures.** Both directions of Highway 84 in Tuscola, Texas, were closed for several hours November 6 after a semi-truck overturned, causing fuel to leak on the roadway. No injuries were reported.

 8. *November 5, Modesto Bee* – (California) **Highway 99 gas tanker crash snarls Modesto traffic, lanes reopen 14 hours later.** Both directions of Highway 99 in Modesto, California, were closed for more than 14 hours November 5 while crews worked to clean up roughly 8,000 gallons of gasoline and diesel fuel that spilled after a fuel tanker veered off the roadway and overturned. The accident remains under investigation and the driver of the tanker truck was transported to an area hospital.

 9. *November 5, KOTV 6 Tulsa* – (Oklahoma) **Soft drink truck crash stops traffic on Cherokee Turnpike.** The westbound lanes of the Cherokee Turnpike at the Highway 59 interchange in Delaware County, Oklahoma, were closed for several hours November 5 after a semi-truck overturned. The cause of the crash remains under

investigation.

10. *November 7, U.S. Department of Agriculture* – (National) **OSI Industries, LLC recalls chicken products due to possible foreign matter contamination.** OSI Industries, LLC issued a recall November 6 for roughly 21,403 pounds of its “On-Cor Chicken Patties Microwaveable” products due to potential foreign matter contamination after the company was notified of 3 consumer complaints concerning the presence of firm blue plastic found in the products. No adverse reactions have been reported and the products were shipped to retail outlets in six States.

11. *November 7, U.S. Food and Drug Administration* – (Pennsylvania) **Crescent Vending Co. issues allergy alert on undeclared (wheat, soy, milk, and egg) in product.** Crescent Vending Company issued a recall November 5 for 21 variations of its pre-packaged food products sold in 4 – 8-ounce containers due to undeclared wheat, soy, milk, and egg. No illnesses have been reported and the products were distributed via refrigerated vending machines that the company owns and operates in Montgomery County, Pennsylvania.

12. *November 4, U.S. Food and Drug Administration* – (National) **McConnell’s Fine Ice Creams recalls select 16oz. packages due to possible health risk.** McConnell’s Fine Ice Creams issued a voluntary recall November 4 for 7 variations of its ice cream products sold in 16-ounce packages that were produced by Dr. Bob’s of Upland, LLC, a contract manufacturer, due to potential contamination with *Listeria monocytogenes*. No illnesses have been reported and the products were distributed to retail outlets in 41 States.

13. *November 4, U.S. Food and Drug Administration* – (National) **OLMA-XXI, Inc. recalls two smoked fish products because of possible health risk.** OLMA-XXI, Inc. issued a recall November 4 for its Premium Norwegian Salmon Smoked and Salmon, Turbot, Butterfish Smoked products sold in 8-ounce packages due to potential contamination with *Listeria monocytogenes* discovered during routine sampling by the Florida Department of Agriculture and Consumer Services, Division of Food Safety. No illnesses have been reported and the products were distributed via retail establishments and warehouses in 13 States.

14. *November 7, WPMT 43 York* – (Pennsylvania) **Boil water advisory in effect in Duncannon, Perry County.** Duncannon Borough Water System officials in Perry County, Pennsylvania, issued a boil water advisory for the system’s customers November 7 after disinfection system equipment failed at one of the borough’s wells. 15. *November 7, WLWT 5 Cincinnati* – (Indiana) **Police: SE Ind. water treatment plant burglars came into contact with E.coli.** Authorities in Versailles, Indiana, reported a November 5 – November 6 burglary and vandalism incident at a local wastewater treatment plant. Officials stated that the suspected individual came into contact with E. coli strains located in an incubator at the plant site. 16. *November 4, Greenville Upstate Business Journal* – (South Carolina) **Data breach affects 2,500 GHS patients.** Officials from Greenville Health System’s Carolina Cardiology Consultants announced November 4 that it notified around 2,500 patients of a potential data breach after the patients’ records containing personal information were improperly downloaded by a former employee of Ambucor Health Solutions, a company providing remote-monitoring services for cardiac devices. 17. *November 6, WTNH 8 New Haven* – (Connecticut) **Oil line rupture forces Monday closure of East Lyme High School.** East Lyme High School in East Lyme, Connecticut, was closed November 7 while crews worked to repair a ruptured oil line. 18. *November 4, KIVI 6 Nampa* – (Idaho) **The Boise National Forest’s Pioneer Fire is officially 100% contained.** Crews reached full containment November 3 of the Pioneer Fire, which burned nearly 300-square miles in the Boise National Forest in Idaho. The U.S. Forest Service has begun rehabilitation efforts and dispatched emergency response teams to identify potential hazards. 19. *November 7, SecurityWeek* – (International) **Critical privilege escalation flaws found in MySQL.** Oracle Corporation released updates for its MySQL database management systems after a security researcher discovered an arbitrary code execution flaw and race condition issue in MySQL that a malicious actor could chain together to escalate privileges to root and fully compromise a targeted system. Percona released an update for its Percona Server for MySQL and Percona XtraDB cluster to address the same vulnerabilities in its software, and MariaDB released a patch for the race condition flaw in its software.

20. *November 5, SecurityWeek* – (International) **Android spyware targets executives.** Security researchers from Skycure discovered an Android spyware, dubbed Exaspy could be leveraged to access a victim's chats and messages, record audio during calls or in the background, take screenshots, and collect contact lists and call logs, among other malicious actions. The researchers found that the malware required physical access to a targeted device for installation, and once installed, the app runs under the name Google Services, disguising itself as the legitimate Google Play Services.

No injuries were reported and Cushing Public Schools were closed November 7 to assess potential damages.

23. *November 5, KSTU 13 Salt Lake City* – (Utah) **At least 30 residents displaced in Price after treadmill ignites in gym.** At least 30 residents were displaced after an apartment fire in Price, Utah, November 5 that damaged 15 of the 22 units in the building. No injuries were reported and authorities believe the fire began after a treadmill malfunctioned and ignited, and then spread to the residences above the gym.
