1. *November 21, Forum of Fargo-Moorhead* – (North Dakota) **Oil spill reported, contained near Killdeer, N.D.** The North Dakota Industrial Commission, Oil and Gas Division reported that crews contained around 16,800 gallons of oil that spilled after a valve at an oil well on the Fort Berthold Indian Reservation near Killdeer failed November 19.

2. *November 20, Asbury Park Press* – (New Jersey) **Turbine fault shuts down Oyster Creek power plant.** Exelon Corp.'s Oyster Creek Nuclear Generating Station in Lacey Township, New Jersey, shut down automatically November 20 due to a fault in the plant's turbine control system. Crews worked to repair and test the system before returning it to service.

3. *November 22, Victorville Daily Press* – (California) **Head-on crash shuts down Highway 395; three transported to local hospitals.** A head-on collision injured 3 people and forced the closure of both directions of Highway 395 in Victorville, California, for several hours November 21. The crash remains under investigation.

4. *November 19, WVEC 13 Hampton* – (Virginia) **Plane lands on belly, delays dozens of flights at Norfolk airport.** Dozens of incoming and outgoing flights at Norfolk

International Airport in Virginia were diverted or delayed for 3 hours November 19 after a Malibu Piper Aircraft was forced to make an emergency landing at the airport when the plane lost power immediately after takeoff. Crews removed the plane with a crane and were working to clear the debris from the runway.

5. *November 19, WPEC 12 West Palm Beach* – (Florida) **Lanes reopen after overturned semi-truck shuts down I-95.** All northbound lanes of Interstate 95 in Hobe Sound, Florida, reopened after being closed for several hours November 19 while crews worked to clear the wreckage after a semi-truck overturned. HAZMAT crews responded and cleaned up fuel that spilled during the crash.

6. *November 21, U.S. Food and Drug Administration* – (National) **Allergy alert issued on mislabeled product for undeclared milk and soy in Heinz Homestyle Bistro Au Jus Gravy.** The Kraft Heinz Company issued a voluntary recall November 19 for roughly 500 cases of its Heinz HomeStyle Bistro Au Jus Gravy products sold in 12-ounce jars after it was discovered that some of the jars may be misbranded as Heinz Pork Gravy and therefore may not indicate the presence of milk and soy. No consumer complaints or illnesses have been reported and the products were distributed to retail outlets nationwide.

Water and Wastewater Systems Sector

7. *November 22, WJHG 7 Panama City/WECP 18 Panama City* – (Florida) **Health advisories issued after 2,800-gallon sewage spill.** Florida Department of Health officials issued a health advisory for Lake Vivien, also known as Lake Clyde, and the Choctawhatchee Bay in Shalimar November 21 after 2,800 gallons of sewage spilled at the intersection of Bayshore Drive and Palm Boulevard following the overflow of a wastewater manhole. Crews contained the spill and health officials reported that the sewage did not contaminate any drinking water sources.

8. *November 21, WTAP 15 Parkersburg* – (Ohio) **Marietta under boil advisory as Harmar water tank put back into service.** Marietta, Ohio officials issued a boil water advisory for the city November 21 while the 100,000 gallon Harmar Water Tank returned to service after it was temporarily decommissioned in September to complete repair work. Officials stated the advisory would continue through November 22.

9. *November 21, U.S. Food and Drug Administration* – (National) **Cantrell Drug Company issues voluntary recall of select sterile drug products due to lack of sterility assurance.** Cantrell Drug Company issued a voluntary recall out of an abundance of caution November 18 for select unexpired sterile drug products due to lack of sterility assurance following an inspection at the company's facility. The firm has not received reports of adverse reactions and the products were distributed to health care facilities nationwide.

10. *November 21, U.S. Food and Drug Administration* – (National) **Tri-Coast Pharmacy Inc. voluntary recalling all sterile products prepared between May 17, 2016 and November 17, 2016 due to concern over lack of sterility assurance.** Tri-Coast Pharmacy Inc. issued a voluntary recall November 18 for all of its unexpired sterile products due to U.S. Food and Drug Administration concerns regarding the lack of sterility assurance. There have been no reports of adverse reactions and the firm urged consumers to discontinue the use of any products included in the recall.

11. *November 22, Chattanooga Times Free Press* – (Tennessee) **6 students in ICU after school bus driver charged in crash that killed Woodmore Elementary students.** The U.S. National Transportation Safety Board is investigating after a school bus transporting 37 Woodmore Elementary School students overturned and crashed into a tree in Chattanooga, Tennessee, November 21, killing 5 students and hospitalizing 12 others. The driver was arrested and charged following the incident.

12. *November 22, Softpedia* – (International) **US Government invites hackers to attack US Army domains.** The U.S. Department of Defense (DOD) and partner company HackerOne reported November 22 that hackers can now register for the Hack the Army bug bounty challenge, which will allow 500 security researchers to hack U.S. Army domains and find unpatched vulnerabilities in exchange for a reward. DOD officials reported the program concerns any public-facing Website that is owned, operated, or controlled by the department, and is part of an effort to explore new security approaches.

13. *November 22, Staunton News Leader* – (Virginia) **Wildfire spreads in national forest.** About 70 fire personnel worked November 22 to contain a roughly 2,700-acre wildfire burning in the Mount Pleasant National Scenic Area of the George Washington and Jefferson National Forest in Amherst County, Virginia. Crews began line construction efforts to help contain the fire.

14. *November 22, WHKY 14 Hickory* – (North Carolina) **Wildfire at South Mountains State Park reported to be 50% contained.** Roughly 350 fire personnel reached 50 percent containment November 22 of the roughly 6,433-acre Chestnut Knob Fire burning in the South Mountains State Park in North Carolina. Crews were assessing potential damage to trail areas and stream crossings.

15. *November 22, Asheville Citizen-Times* – (North Carolina) **Chimney Rock reopens Friday, Santa arrives Dec. 3.** Officials reported that the Chimney Rock attraction at Chimney Rock State Park in North Carolina will reopen November 25 after being evacuated November 11 due to the roughly 7,100-acre Party Rock Fire burning in Lake Lure. The Rumbling Bald section of the park remains closed while crews continue to fight the fire.

16. *November 21, Easton Express-Times* – (Pennsylvania) **Scrawled bomb threat causes school evacuation.** Classes were canceled at Lehigh Career and Technical Institute in Schnecksville, Pennsylvania, November 21 after a student found a handwritten bomb threat in the hallway of the school that prompted the evacuation of faculty and students for roughly 2 hours. Authorities deemed the area safe after determining the threat was a hoax.

17. *November 21, Denver Post* – (Colorado) **Former chief of Sterling, Eagle fire departments pleads guilty to theft, official misconduct.** The former chief of the Sterling Fire Department in Colorado pleaded guilty November 17 to stealing over \$20,000 from the department after he was accused of stealing more than \$120,000 between 2010 and 2015 and using the money for personal expenses. The theft was discovered after Sterling city officials noticed bookkeeping inconsistencies and missing firefighting equipment after the former chief left the department in April 2016.

Information Technology Sector

18. *November 22, SecurityWeek* – (International) **Office 365 flaw made fake Microsoft emails look legitimate.** A Turkey-based security researcher discovered a flaw in Microsoft Office 365 that could be exploited by attackers to send malicious emails and make them appear as if they were sent from a legitimate microsoft.com email address

after a test of different email services' spam filters found that some of his phishing emails that were marked as valid came from a spoofed microsoft.com address and were forwarded through Outlook 365 to the Yandex email service. Additional testing found that Gmail also accepted the spoofed microsoft.com emails that were forwarded from Outlook as legitimate.

19. *November 21, SecurityWeek* – (International) **Code execution flaws patched in HDF5 library.** The HDF Group released version 1.8.18 of its HDF5 library after researchers from Cisco's Talos Vulnerability Development Team discovered the library was plagued with a total of 4 local heap-buffer overflow flaws that could allow an attacker to execute arbitrary code in the context of the application using the library if they trick a victim into opening a maliciously crafted file. The vulnerabilities are the result of a failure to check if the number of dimensions for an array from a file is within bounds, failure to check if certain message types support a specific flag, and insufficient handling of select values in memory when parsing a Hierarchical Date Format (HDF) file, among other failures.

20. *November 22, WGNO 26 New Orleans* – (Louisiana) **Back to back fires gut Buttermilk Drop Bakery.** The Buttermilk Drop Bakery & Cafe in New Orleans was destroyed following 2 fires November 21 – November 22, including a 2-alarm blaze that engulfed the entire facility and took firefighting crews approximately 3 hours to control. No injuries were reported in the two fires and the cause of the second fire remains under investigation.
