Top Stories

- More than 9,000 gallons of fuel spilled from an overturned tanker truck in Cape Coral, Florida, November 27 and caught fire, prompting officials to evacuate all residents within a half-mile radius of the spill for several hours. – *WBBH 20 Fort Myers* (See item [1](#))

1. *November 28, WBBH 20 Fort Myers* – (Florida) **Leaking fuel tanker catches fire in Cape, causes evacuations.** More than 9,000 gallons of fuel spilled from an overturned tanker truck on Del Prado Boulevard in Cape Coral, Florida, November 27 and caught fire, prompting officials to evacuate all residents within a half-mile radius of the spill for several hours. A portion of the road was shut down for several hours while officials worked to clean up the gasoline and contain the fire.

2. *November 26, WHIO 7 Dayton* – (Ohio) **Yamada auto parts plant evacuated after bomb threat.** The Yamada North America Inc. auto parts manufacturing plant in South Charleston, Ohio, was evacuated for roughly 2 hours November 26 after a written bomb threat was discovered on a bathroom wall. Authorities cleared the building and employees were allowed to reenter.

3. *November 28, Waco Tribune-Herald* – (Texas) **Overtaken truck snarls I-35 in Lorena.** The southbound lanes of Interstate 35 in Lorena, Texas, were closed for several hours November 27 after a semi-truck carrying aluminum rolls overturned, spilling 3 of the rolls on the roadway. No injuries were reported.

4. *November 28, KRQE 13 Albuquerque* – (New Mexico) **Plane headed to Las Vegas makes emergency landing in Albuquerque.** American Airlines Flight 1693 en route

- to McCarran International Airport in Las Vegas from Dallas/Fort Worth International Airport was forced to make an emergency landing at Albuquerque International Sunport in New Mexico November 27 due to mechanical issues.

5. *November 27, Portland Tribune* – (Oregon) **One killed, one injured in Highway 212 crash.** Highway 212 near Damascus, Oregon, was closed for roughly 4 hours November 26 following a 2-vehicle crash that killed 1 person and hospitalized another.

 6. *November 27, Portland Oregonian* – (Oregon) **Woman dies after T-bone crash on Highway 99W near Monmouth.** A 2-vehicle collision on Highway 99 West near Monmouth, Oregon, forced the closure of the highway for approximately 6 hours November 26. One person was killed and another was hospitalized.

 7. *November 27, KTLA 5 Los Angeles* – (California) **3 teenagers among 4 people killed in fiery Gardena crash along 110 Freeway: CHP.** The 110 Freeway interchange with the 91 Freeway in Gardena, California, was closed for more than 7 hours November 27 following a single-vehicle crash that killed 4 people.

 8. *November 26, WHIO 7 Dayton* – (Ohio) **Newlyweds share first dance on shut down U.S. 35.** The westbound lanes of U.S. Route 35 in Dayton, Ohio, were closed for nearly 2 hours November 26 while crews worked to clear the wreckage following a multi-vehicle collision that hospitalized 1 person.

Food and Agriculture Sector

9. *November 27, Pottstown Mercury* – (Pennsylvania) **More local areas named to spotted lanternfly quarantine.** The Pennsylvania Department of Agriculture extended the spotted lanternfly quarantine November 27 to include additional communities in Berks, Chester, and Montgomery counties. Officials advised individuals who find a spotted lanternfly outside of the quarantine zone to contain the specimens in a leak-proof container with alcohol or hand sanitizer and submit the specimens to the county's Penn State Extension office or to the Department of Agriculture's entomology lab for verification.

10. *November 25, U.S. Food and Drug Administration* – (New York) **Anderson’s Frozen Custard issues allergy alert on undeclared peanuts in Pumpkin Ice Cream Pies.** Anderson’s Frozen Custard issued a recall November 22 for its “Pumpkin Ice Cream Pies” products sold in 9-inch containers after it was discovered that the packaging did not declare the presence of peanuts. The products were distributed in Erie and Niagara counties in New York, Anderson’s locations, and via Oliver’s Candies in Batavia.

11. *November 25, U.S. Food and Drug Administration* – (National) **JFC International Inc. issues allergy alert on undeclared wheat in You-ka Fresh Ramune and You-ka Punch Ramune.** JFC International Inc. issued a voluntary recall November 23 for its You-ka Fresh Ramune and You-ka Punch Ramune confectionery products sold in 3.87-ounce packages due to undeclared wheat after it was discovered that the sugar ingredients used in the products may have been contaminated by wheat. No illnesses have been reported and the products were distributed to retail outlets and other foodservice operators in five States.

Water and Wastewater Systems Sector

12. *November 27, Lihue Garden Island* – (Hawaii) **Lanes closed after crash, sewage spill.** Officials from the Kauai County Public Works Department, Wastewater Division reported November 26 that roughly 3,200 gallons of sewage overflowed from a manhole on Kuhio Highway in Hanamaulu, Hawaii, into Hanamaulu Stream due to a partially-blocked sewer line that crosses the stream along the highway. Officials advised the public to avoid the water until further notice.

13. *November 24, Berkshire Eagle* – (Massachusetts) **Hundreds of BMC patients’ info found on vendor’s thumb drives.** Officials from the Berkshire Medical Center in Pittsfield, Massachusetts, reported November 23 that the personal information of 1,745 cardiology patients may have been exposed after the records were discovered on thumb drives recovered from a former employee of Ambucor Health Solutions, an outside service vendor. The thumb drive did not include patients’ Social Security numbers, Medicare, insurance, or financial information, and officials stated there is no evidence the information was misused.

14. *November 28, WSOC 9 Charlotte* – (North Carolina) **Rain to bring some relief to NC wildfires.** Fire crews from 25 States reached more than 50 percent containment November 26 of almost all of the major wildfires burning in western North Carolina,

including 77 percent containment of the 9,036-acre Boteler Fire and 90 percent containment of the 7,145-acre Party Rock Fire. Burn bans remain in effect for 47 counties across North Carolina.

15. *November 26, Cullman Today* – (Alabama) **Bethsadia firefighters EMS resign en masse cite violations bad practices.** Seven members of the Bethsadia Volunteer Fire Department in Cullman, Alabama, resigned November 25 following alleged violations of department by-laws and malpractices within the department that do not meet emergency response standards, causing the department's operations to shut down and leaving it without Emergency Medical Service (EMS) coverage, as well as HAZMAT and certified firefighting staffing. Officials reported the incident also impacts emergency services provided in the nearby Spring Hill and Baldwin communities. Information Technology Sector

16. *November 28, SecurityWeek* – (International) **cURL security audit reveals several vulnerabilities.** The developer of cURL released version 7.51.0 to resolve a total of 11 vulnerabilities following a security audit by Cure53, which revealed the open source tool was plagued with 23 issues and 9 security flaws including 4 high severity issues that could lead to remote code execution. 17. *November 25, SecurityWeek* – (International) **Cerber 5.0 ransomware uses new IP ranges.** Check Point security researchers discovered that version 5.0 of the Cerber ransomware was released and now uses new Internet Protocol (IP) ranges for the command and control (C&C) communication, skips 640 bytes when encrypting a file, targets files that feature the secret extension, and no longer encrypts files smaller than 2,560 bytes, among other new features. Check Point also found that the ransomware leverages spam email campaigns and the Rig-V exploit kit for distribution, and as with previous versions, Cerber 5.0 randomly generates encrypted file extensions using four alphabetic numbers. 18. *November 25, SecurityWeek* – (International) **Flaws in Uber's UberCENTRAL tool exposed user data.** A security researcher discovered several issues in Uber Technologies Inc.'s UberCENTRAL service including a flaw that allows attackers to enumerate users' universally unique identifiers (UUIDs) by sending requests with possible email addresses, and an issue that can be exploited to obtain full names, phone numbers, and email addresses of customers, among other flaws. Uber released patches for the flaws.

19. *November 25, Roseburg News-Review* – (Oregon) **Telephone and internet outage affecting thousands on coast, possible 911 outages.** Approximately 15,000 Charter Communications customers from Florence to Coos Bay, Oregon, were without telephone and Internet service for roughly 9 hours November 25. Officials reported during the outage, customers may not have been able to dial 9-1-1 from a landline, but emergency services were reachable via cell phone.

20. *November 28, New York Daily News* – (New York) **Woman, 85, critically injured in Bronx apartment building blaze.** A 3-alarm apartment fire in the Bronx borough of New York City sent a woman to the hospital and displaced at least 16 families. The cause of the fire remains under investigation.

21. *November 27, WIAT 42 Birmingham* – (Alabama) **Birmingham Fire investigating overnight church fire.** The Broken Vessel United Missionary Gospel Baptist Church in Birmingham, Alabama, was considered a total loss following a November 27 fire. No injuries were reported and the cause of the fire remains under investigation.

22. *November 26, Florida Times-Union* – (Florida) **No one hurt after three-alarm fire torches Arlington gentlemen's club.** A 3-alarm fire at the Gold Club gentlemen's club in Jacksonville, Florida, caused an estimated \$250,000 in damages November 26. No injuries were reported and the cause of the fire remains under investigation.

23. *November 24, Softpedia* – (New York) **Hackers hijack Madison Square Garden payment systems, credit card data at risk.** The Madison Square Garden Company reported November 24 that it detected an attack on its payment system that may have

exposed the credit card information of all of its customers between November 9, 2015 and October 24, 2016, including card numbers, verification codes, cardholder names, and expiration dates. The firm stated the attack took place outside of its network and did not leverage accessories attached to the Point-of-Sale (PoS) systems, and the hack remains under investigation.
